Due to the new wells, we have submitted this Form 2A as required by Rule 303.d.(1). #1 Consultation: Antero's Wildlife Mitigation Plan is applicable to this pad (see attached summary of Mitigation Plan included in Proposed BMP's. #2 Mud Disposal: Antero will bury onsite if meet Table 910 and if there is a provision in SUA which allows for such operation. #4: The proposed Dixon Federal B11 well was used as the reference point for well distance measurements. #14 Water Resources: The depth to ground water was determined by using static water level data of nearest active water well (Permit #219622/Receipt# 0447216). Our reference area is undisturbed ground immediately adjacent and to the west of our proposed well pad, as shown in the "Looking West" location photo.
