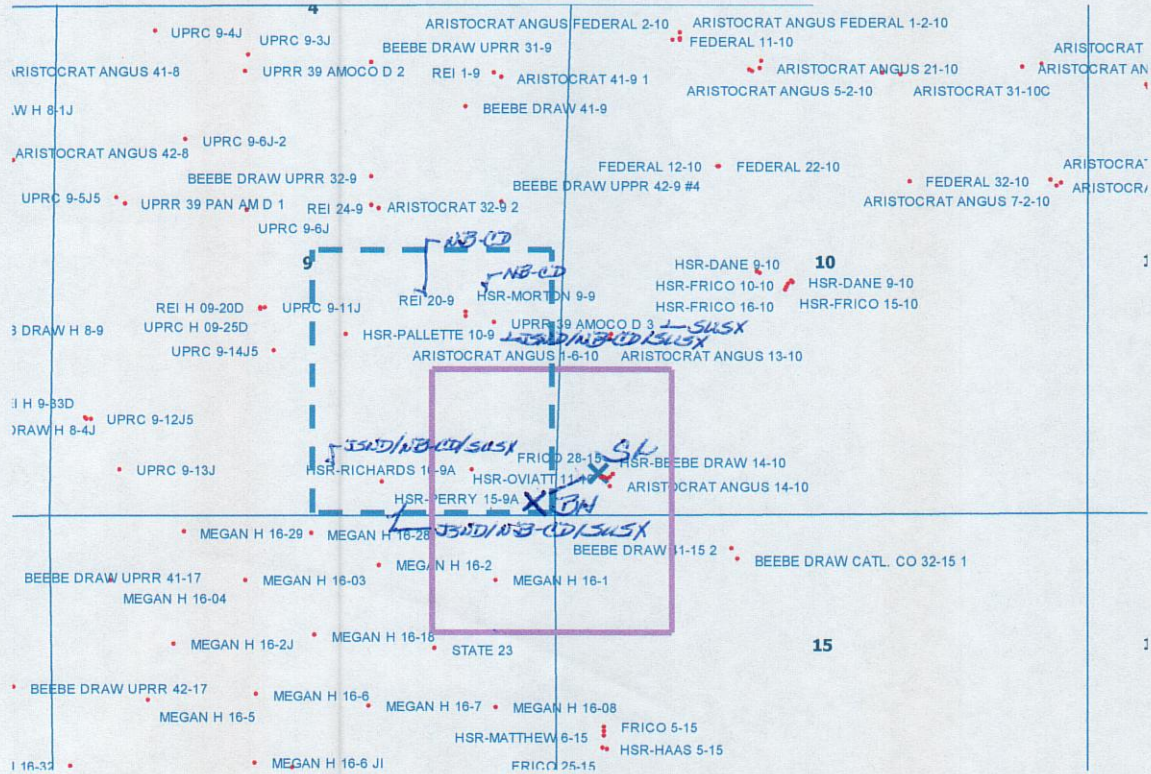

**Proposed 160 acre Spacing Unit (Solid line).**



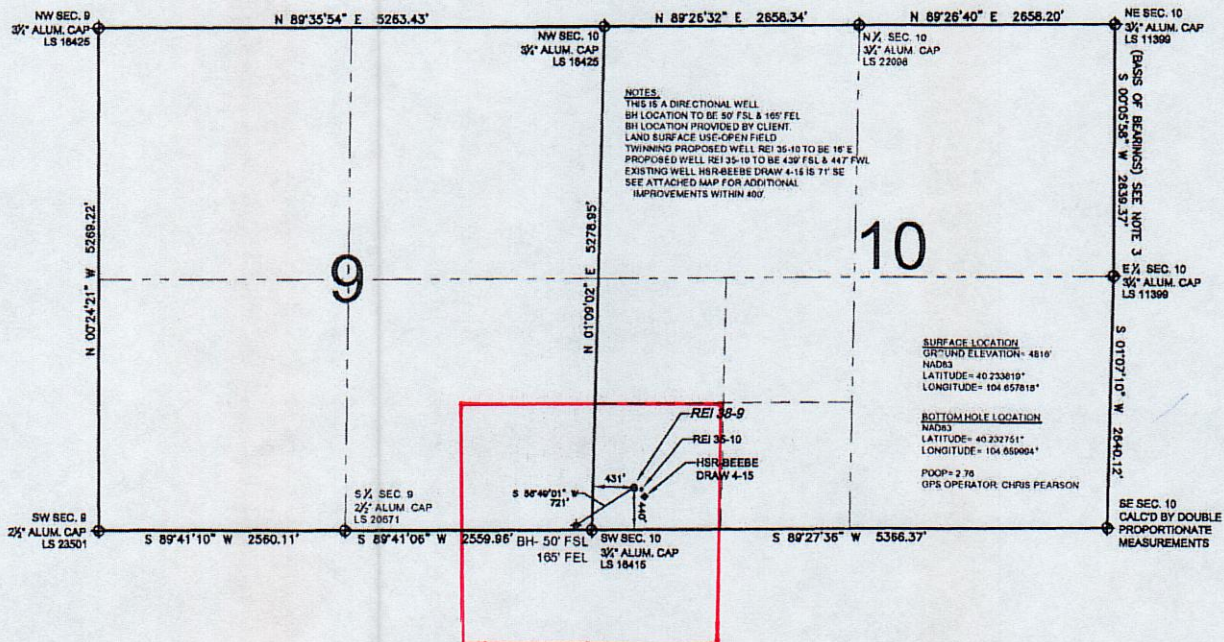
**Bottom Hole Located SE/4SE/4, Sec. 9-T3N-R65W (Dashed line).**

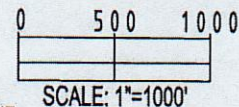
