Railroad is 1.95 +/- miles away from site. There are no visible improvements within 400 feet of site, except a center pivot irrigation system (see well location plat). Nearest water well 629 +/- feet from site (RECEIPT: 9053654; PERMIT: 15333-FP; USE: Irrigation). There is a dry, ephemeral stream located 260 +/- feet north of location. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. A Pump Jack may be necessary to place on facility in the future to help with gas production. It will require either one gas or one electric motor to run the pumping jack unit which will be determined at the time of installation.
