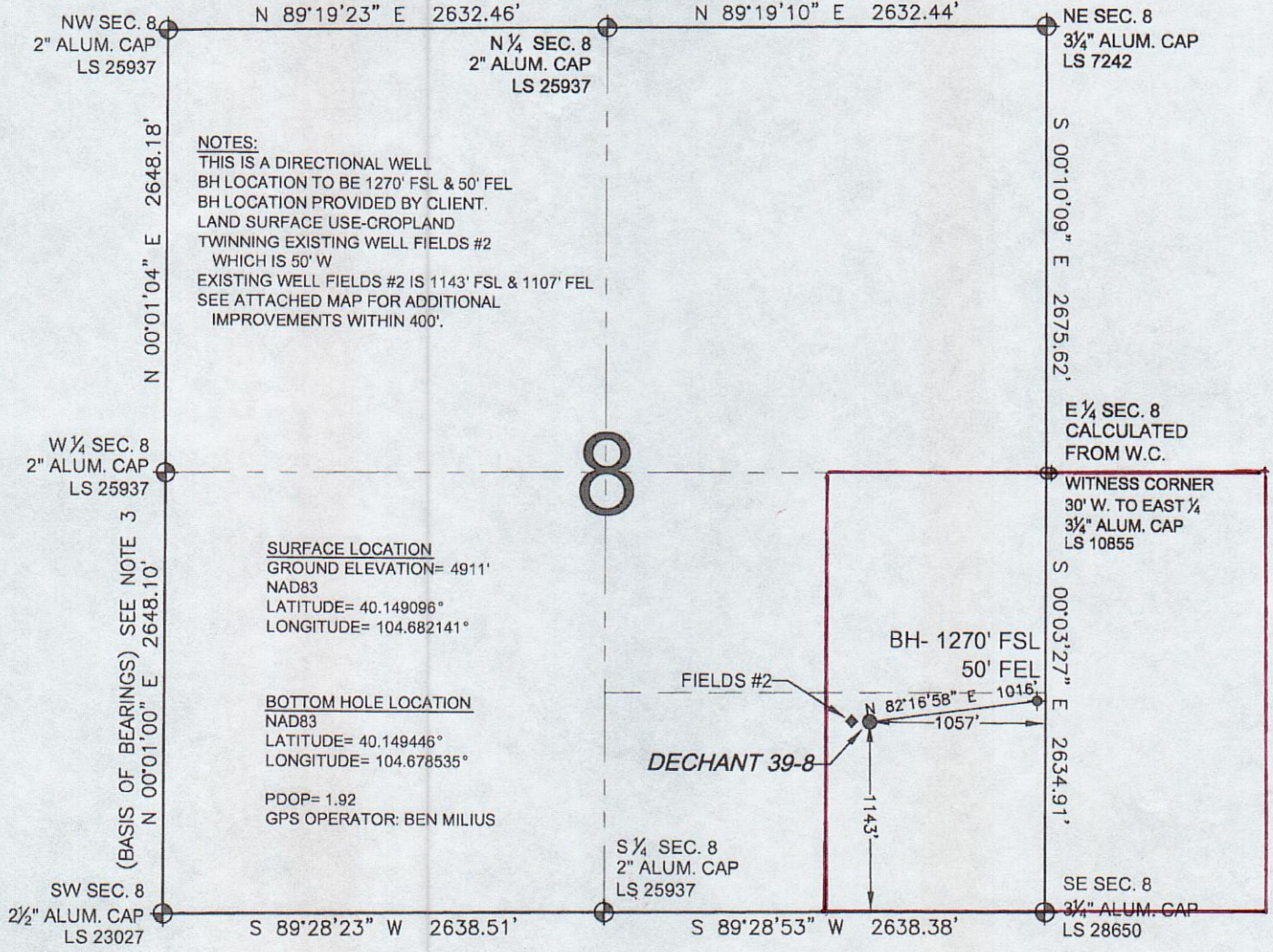

WELL LOCATION CERTIFICATE: DECHANT 39-8

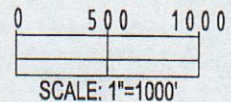

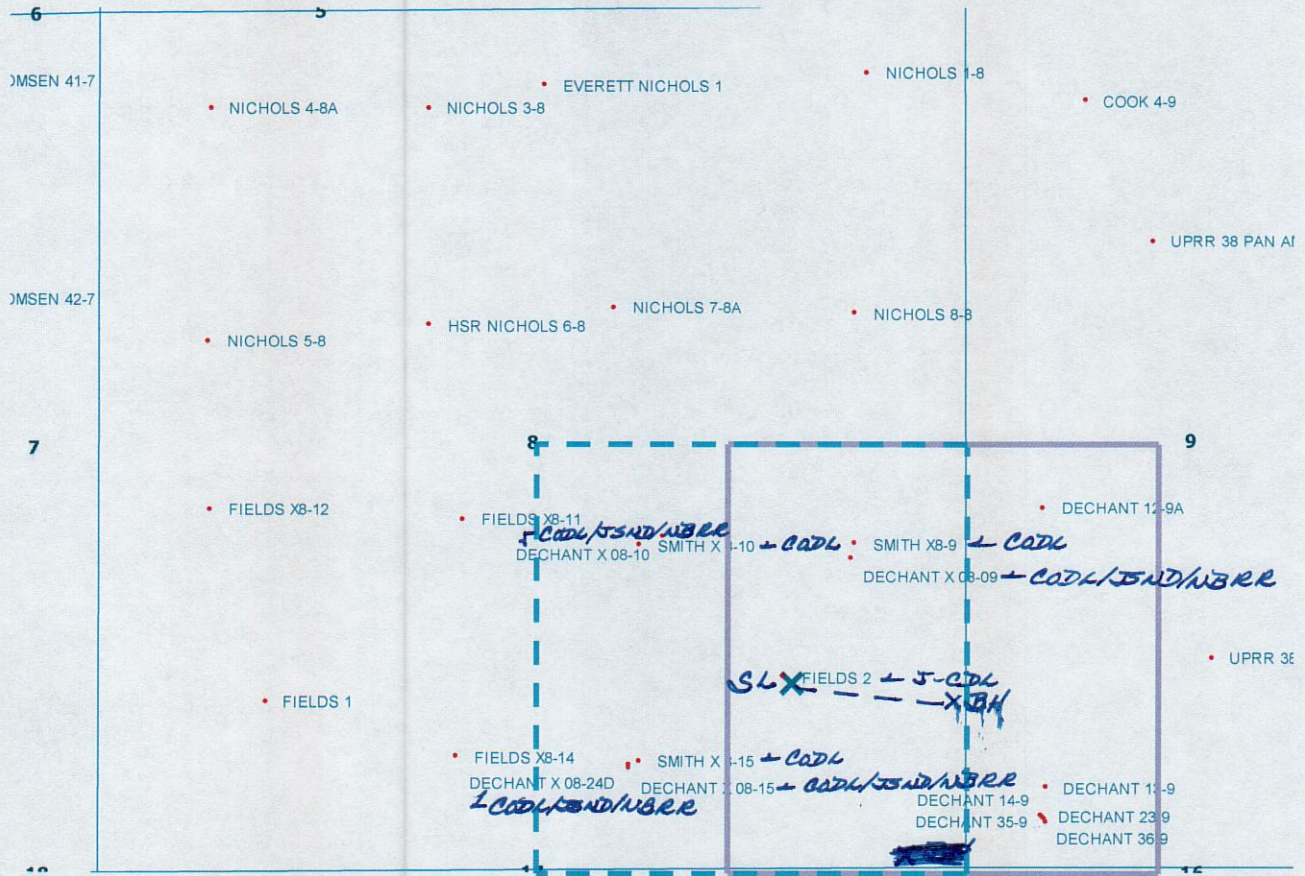
