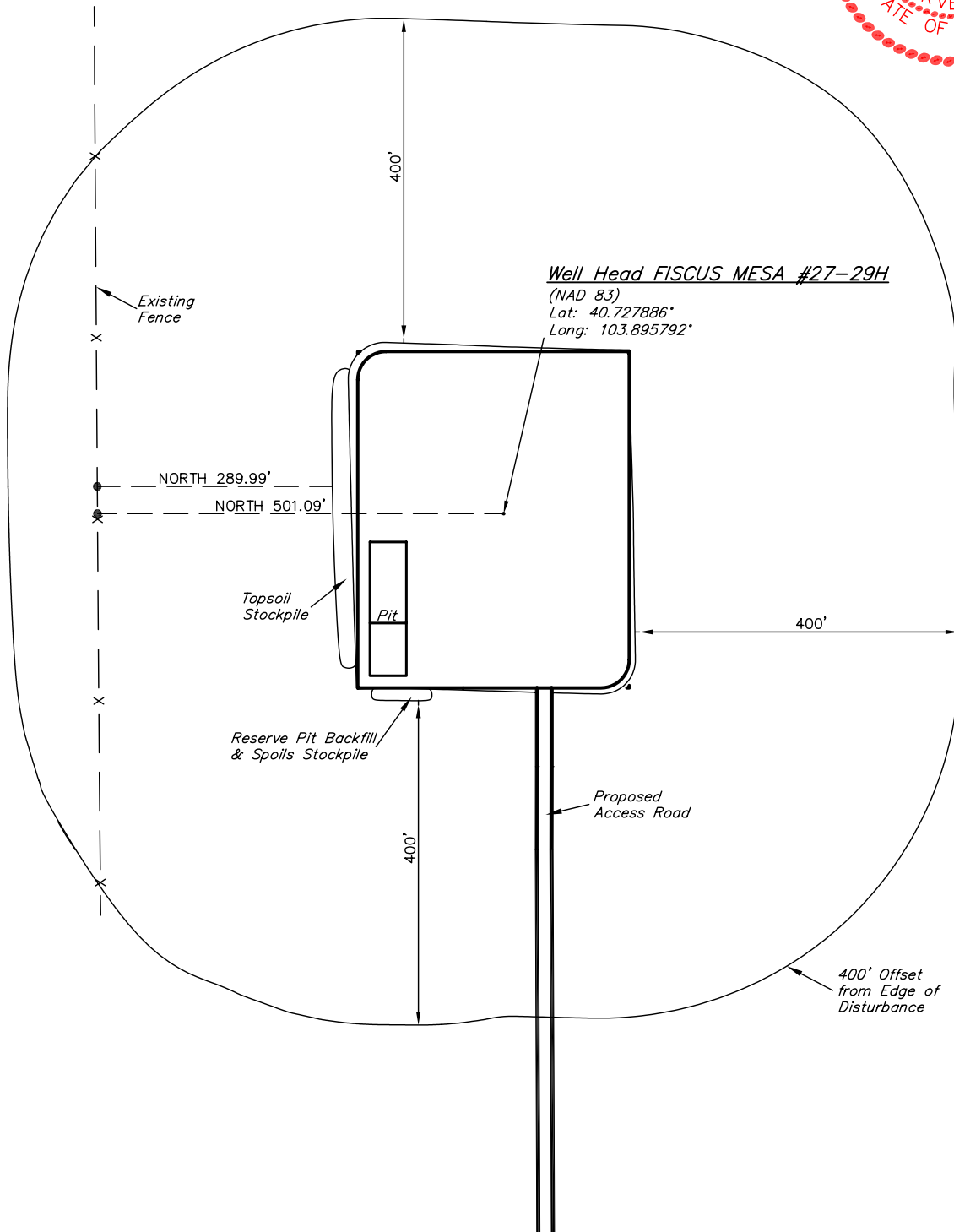

## CONSTRUCTION LAYOUT FOR

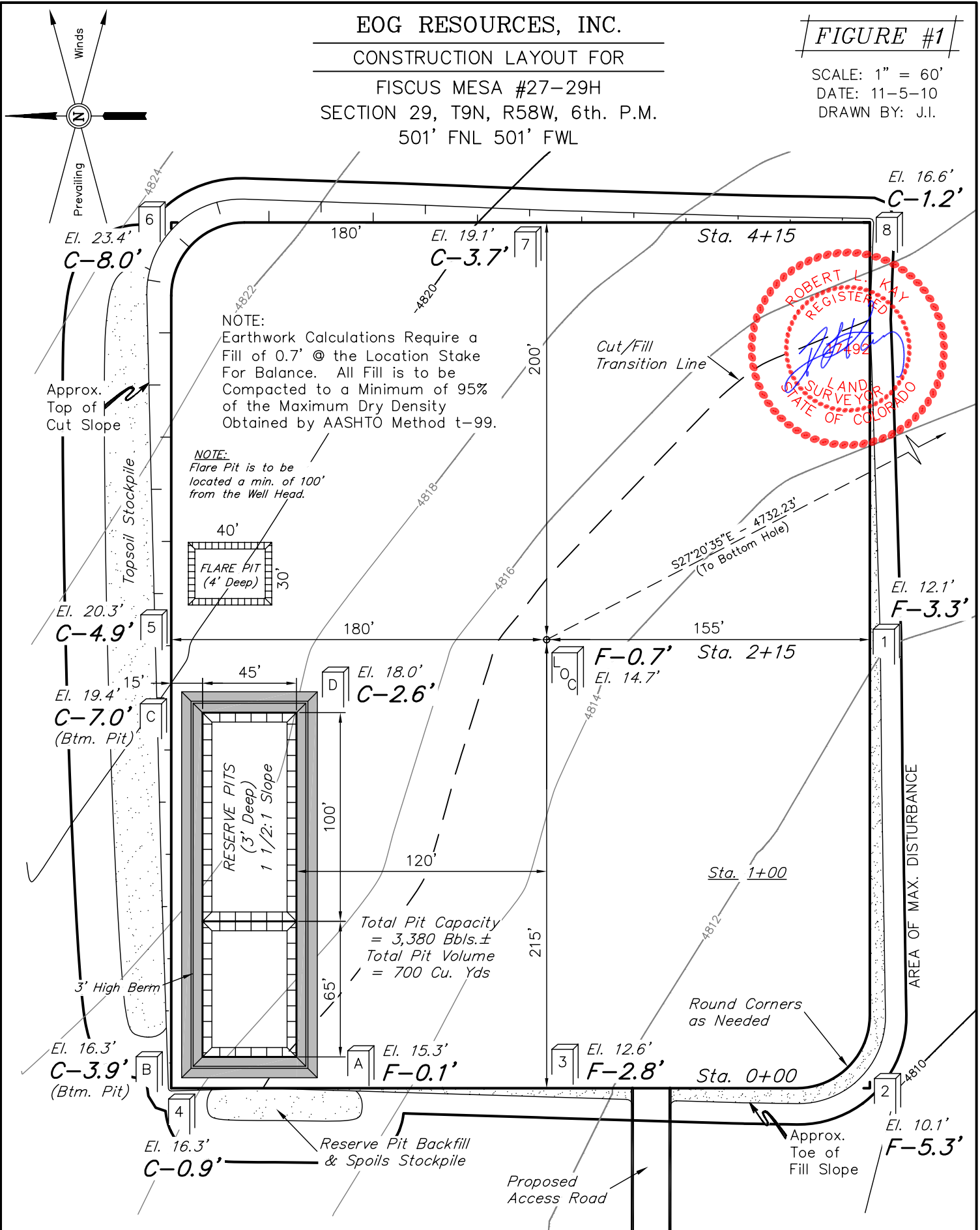

FINISHED GRADE ELEV. AT LOC. STAKE = **4815.4'**

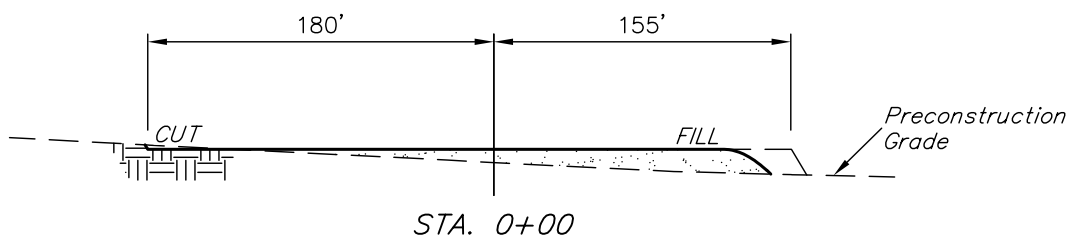
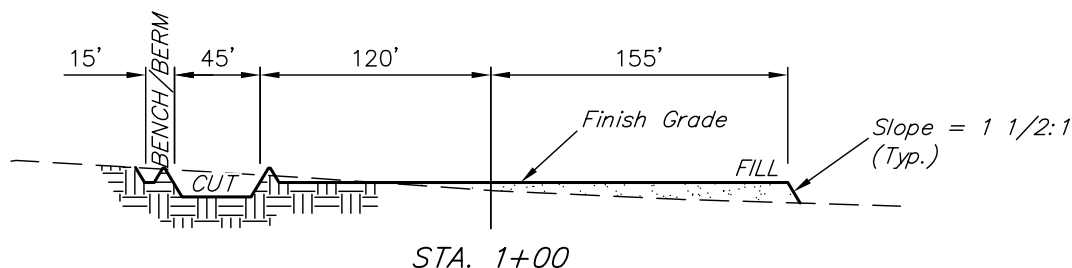
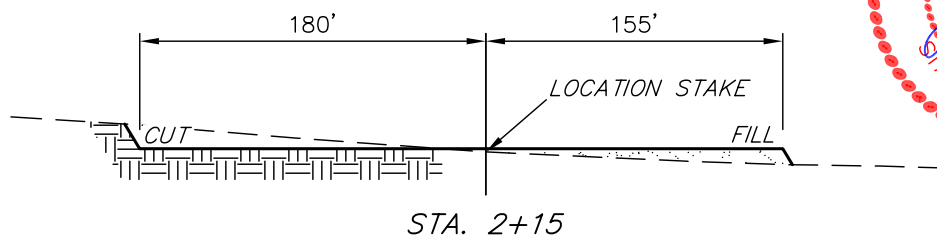
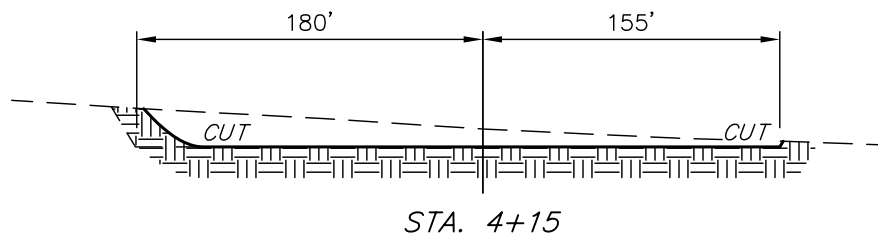

## TYPICAL RIG LAYOUT FOR

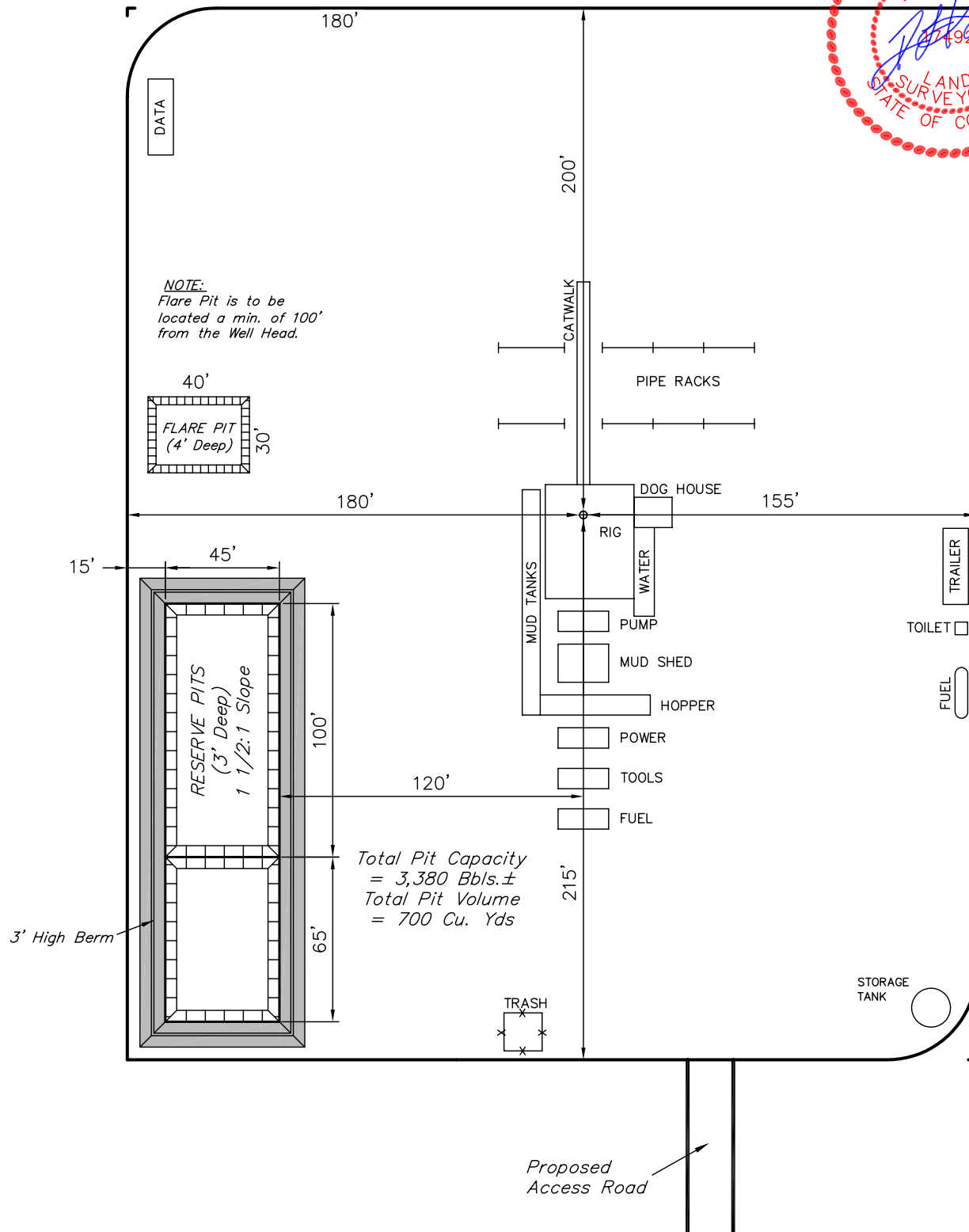
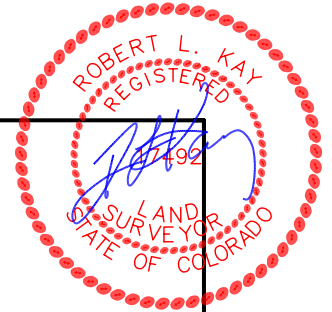
