Water well permit # 256400 was used to find depth to ground water. Nelson 14-32D was used as the reference point on the well pad to measure all distances. Conductor casing will not be used. The Nelson 13-32D, 23-32D, 14-32D, 24-32D, 32BD will all be drilled from the same pad. The wells will be tied into a new tank battery facility approximately 991 feet to the southwest of the drill pad.
