Well water Permit #78833 was used to find depth to ground water and measures 1445' from the wellbore. The Wilson 34-34H will be tied to a tank battery facility onsite. The reference area is immediately adjacent to the location on undisturbed ground to the north and to the west as shown in the northerly and westerly location pictures.
