The nearest permitted water well is permit #:62127-F - located NENW Sec. 27 5N 65W, 1300'N 1420'W, ~ 110' from the location reference point. It is designated as an irrigation well, and was not drilled. Static water level determined from water well permit #: 7246- - located NENW Sec. 27 5N 65W, ~ 884' N-NE of the location. This is also the closest permitted well designated for domestic use, and is also the closest physical well to location, thus this distance was been used to determine distance to the nearest water well. Operator is in the process of executing an SUA with the surface owner.
