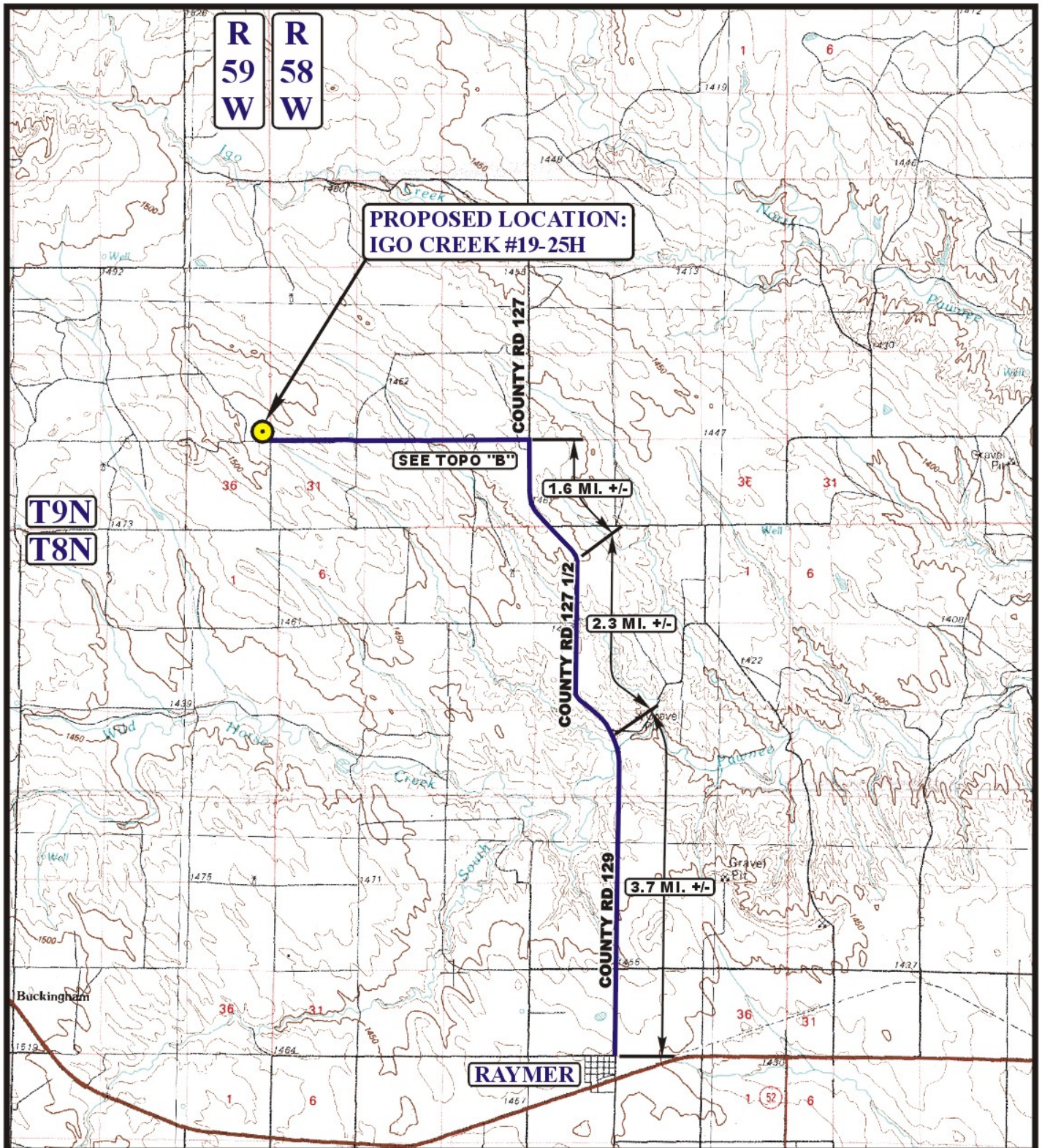


EOG RESOURCES, INC.

PROCEED IN A NORTHERLY DIRECTION FROM RAYMER, COLORADO ALONG COUNTY ROAD 129 APPROXIMATELY 3.7 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 127 ½ TO THE NORTHWEST; TURN LEFT AND PROCEED IN A NORTHWESTERLY, THEN NORTHERLY DIRECTION APPROXIMATELY 2.3 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 127 TO THE NORTHWEST; TURN LEFT AND PROCEED IN A NORTHWESTERLY, THEN NORTHERLY DIRECTION APPROXIMATELY 1.6 MILES TO BEGINNING OF THE PROPOSED ACCESS FOR THE FISCUS MESA #27-29H TO THE WEST; FOLLOW ROAD FLAGS IN A WESTERLY DIRECTION APPROXIMATELY 10,427' TO THE BEGINNING OF THE PROPOSED ACCESS TO THE WEST; FOLLOW ROAD FLAGS IN A WESTERLY, THEN NORTHERLY, THEN WESTERLY DIRECTION APPROXIMATELY 5,823' TO THE PROPOSED LOCATION.

TOTAL DISTANCE FROM RAYMER, COLORADO TO THE PROPOSED LOCATION IS APPROXIMATELY 10.7 MILES.

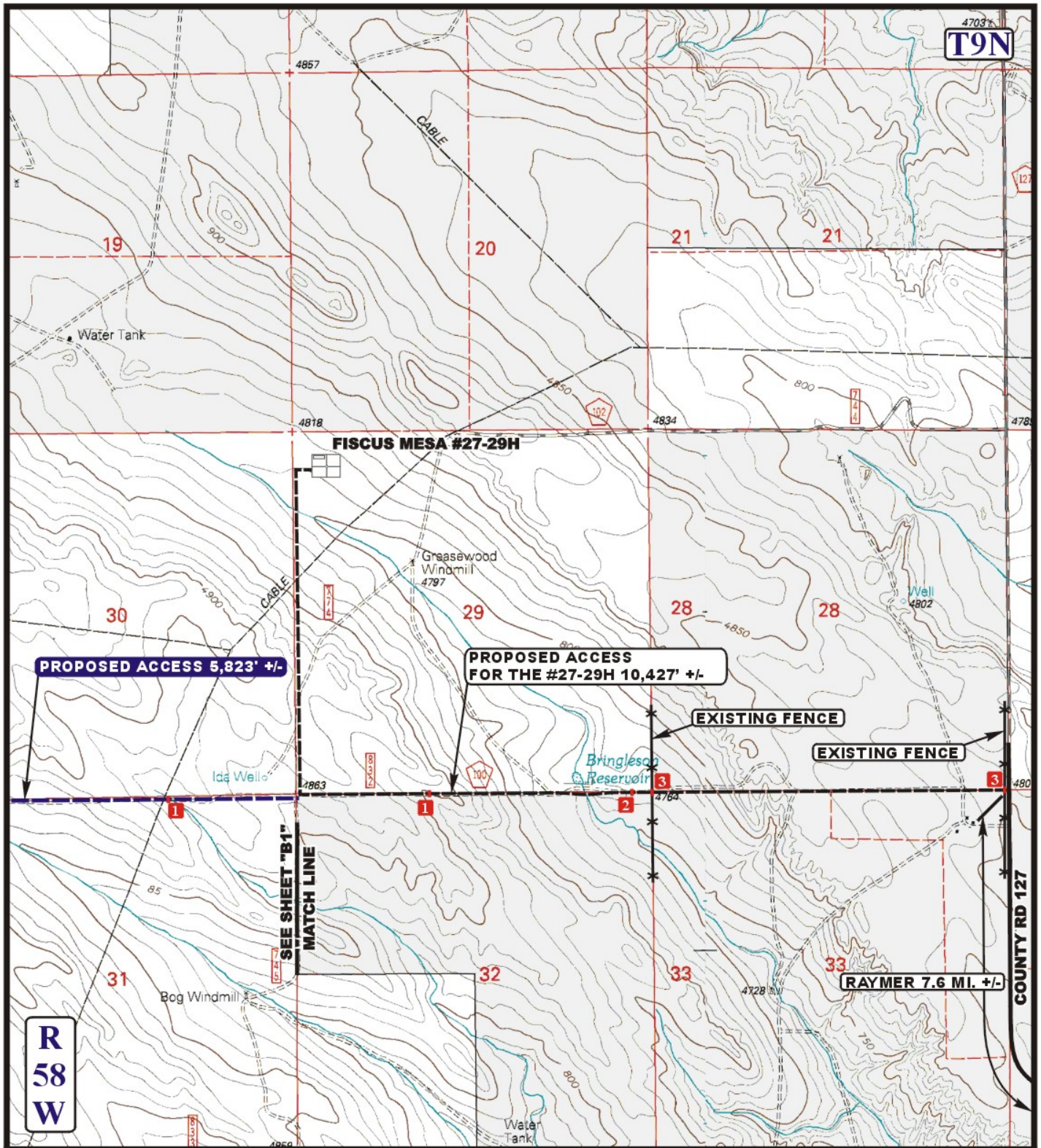
