The placement of the facilities is in the same disturbance as the well therefore a prod equip loc drawing has been included for placement purposes. Closest WW, permit 214467 listed "status unknown" so next closest permit #283853 was used for static level and distance. Surface water is approximately 4197 ft west of the proposed location according to the COGCC topo map. However the aerial map shows the creek as being disturbed by an irrigation circle. Reference area is on undisturbed ground immediately adjacent to and north of the location as shown in the reference area photo facing north. This location will have facilities for the Wells Ranch PC AA22-12, 22-13, 22-25 and 22-20D.
