A Form 2A is being submitted as required by Rule 303.d.(1). #1 Consultation: Antero's Wildlife Mitigation Plan is applicable to this pad (see attached summary of Mitigation Plan included in Proposed BMP's.) #2: Mud Disposal: Antero will bury onsite if disposal meets Table 910 and if there is a provision in SUA which allows for such operation. #4: The Left Hand Federal A1 well was used as the reference point for well distance measurements. #14 Water Resources: The depth to groundwater was determined by using static water level data of nearest water well (Permit #234709). Our reference area is undisturbed ground immediately adjacent and to the East of our proposed well pad, as shown in the "Looking East" photo.
