Based on field inspection, water well permit #47071 is not where COGCC map shows it to be. Nearest water well at 246' is an abandoned domestic/stock well; Receipt #0453696, Permit #222071- -. Next nearest water well; Receipt 3606241, Permit 270084- - with a depth of 800' and a static water level of 408'. Facility location includes the following existing equipment for the existing Miller Red X31-2D and Miller X31-5Ji: 1 tank, 1 separator, 1 gas pipeline, 1 EFM, 1 water vault, 1 VOC burner, & 2 3-phase flowlines.
