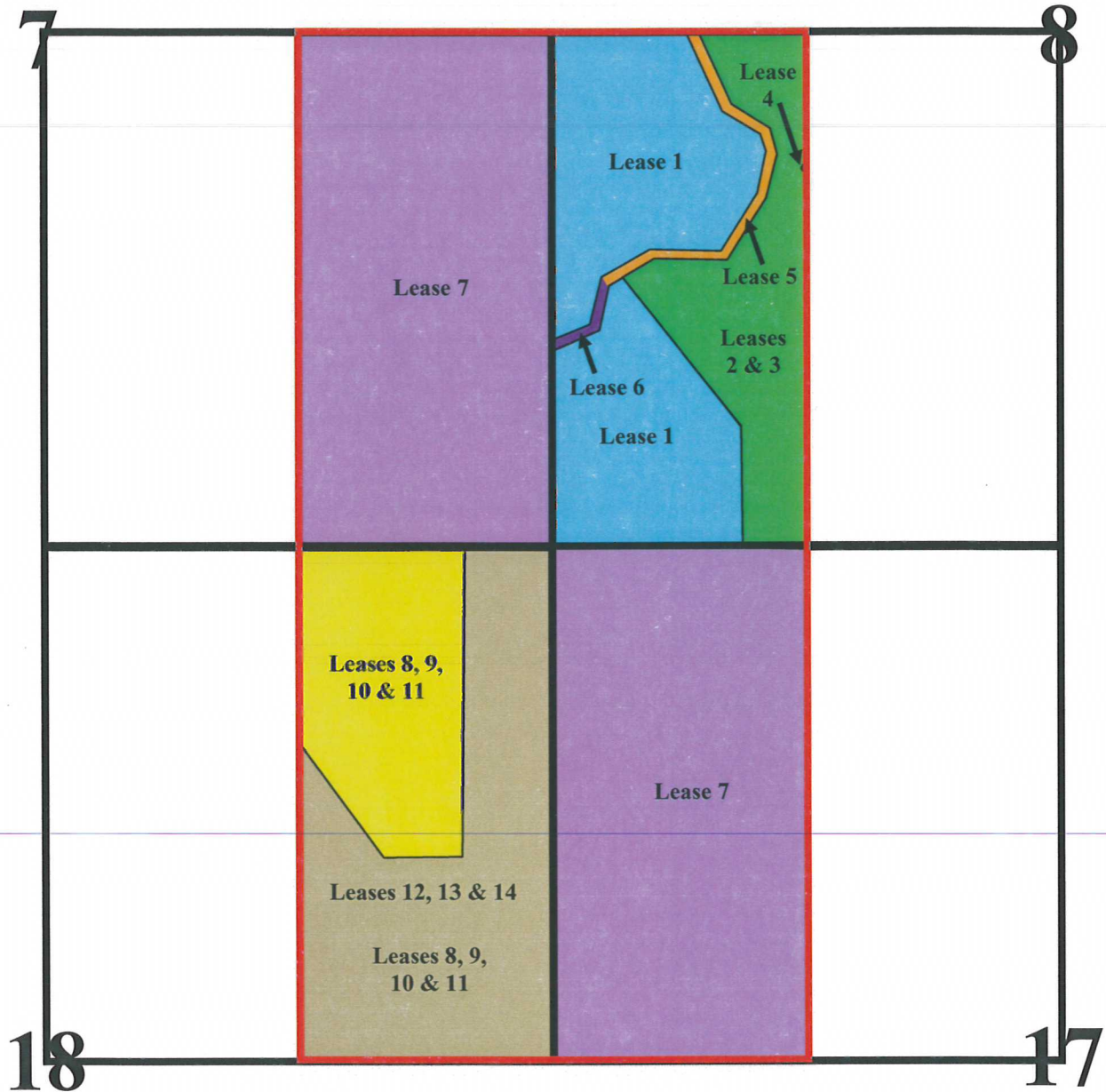


Lease Map – Frick C17-79HN
