3/31/09: Built to 190 psi in 3 days, blew dead in 30 minutes. Had a slight mist of water when blown down. We would like to request a 90 day vent period. Verbally approved by David Andrews 03/31/2009.

07/13/2009: Completed 90 day vent period on 7-1-2009. Builds to 210 psi, blows dead in 15 min, light fluid. We would like to request another 90 day vent period. Verbally approved by David Andrews on 07/13/2009. Any fluids will be collected, stored, and disposed of as per Colorado Series 900 rules.

01/28/10: completed 180 day vent period. Built to 182 psi in 3 days, blew down in 2 minutes through 1/2" valve, no fluid. Requesting additional vent period.

9-15-10: Encana requests approval to open and vent the bradenhead on this well indefinitely. A 7-day pressure build-up will be obtained and, if that pressure builds to 150 psi or greater during that time, it will be reported on a Form 17. All 7-day build-up pressure data will be reported in our annual report no later than November 1st.
