THENCE S88°04'26"W A DISTANCE OF 5249.06 FEET TO A 2" U.S.G.L.O. BRASS CAP MARKED ACCORDINGLY,

THENCE N00°57'21"E A DISTANCE OF 2622.33 FEET ENDING AT A 2" U.S.G.L.O. BRASS CAP MARKED ACCORDINGLY.




