Location is in a sensitive area because of potential for adverse impacts to ground water/surface water; therefore all pits will be lined

Location fill is on steep slopes; therefore the slope should be constructed in such a manner to manage site drainage and slope stability. The slope vegetation should be established immediately after the slope has been constructed.
