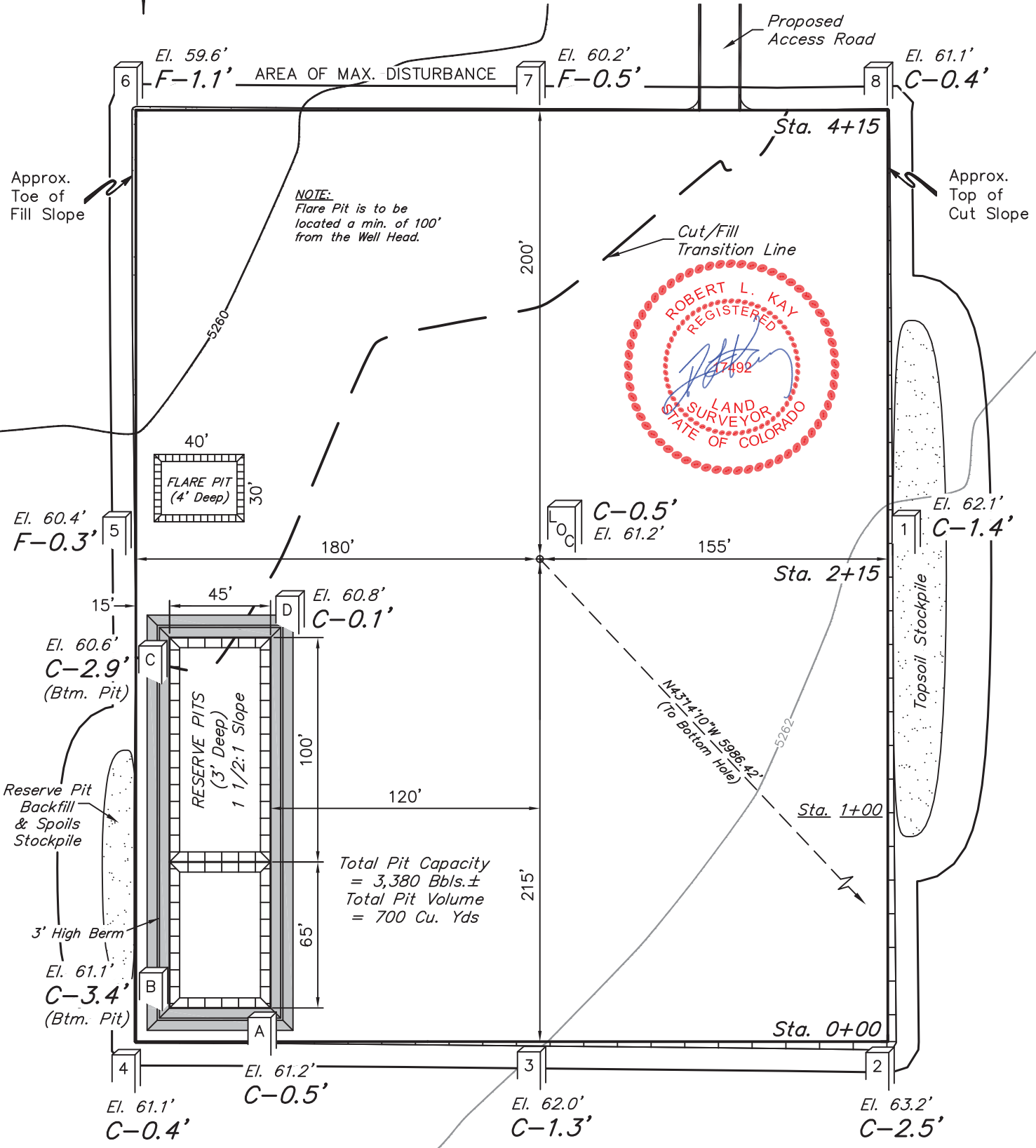

FINISHED GRADE ELEV. AT LOC. STAKE = 5260.7'

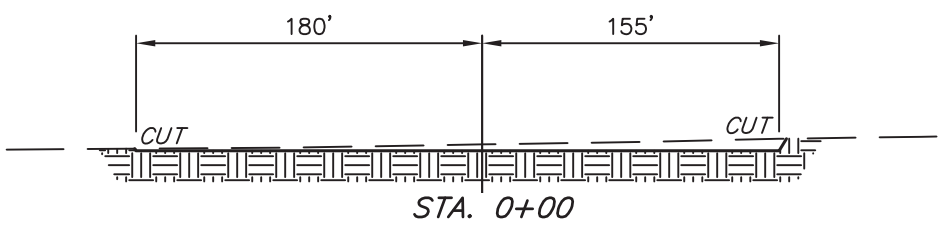
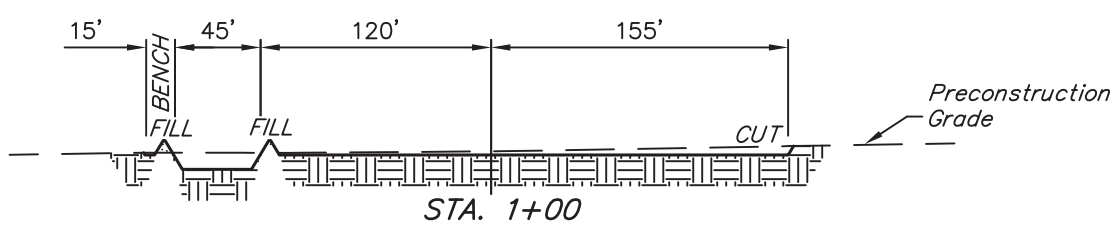
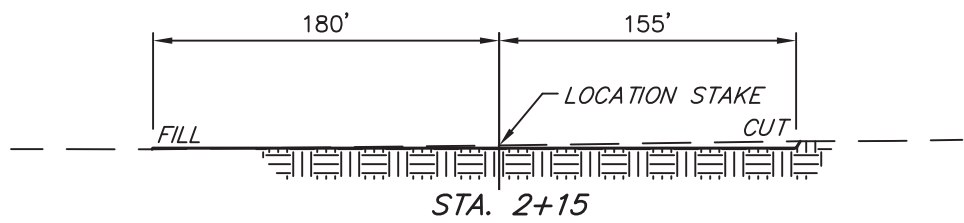
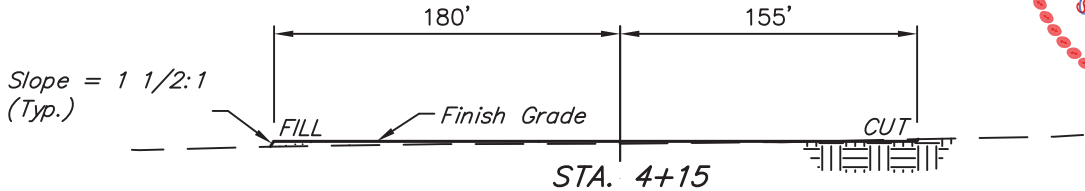

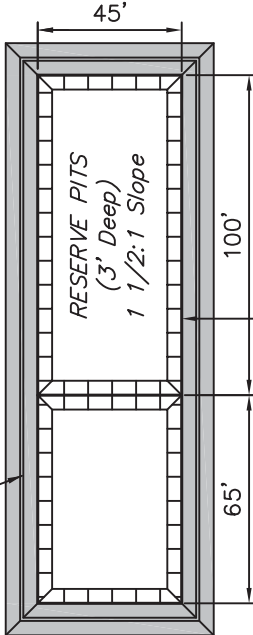

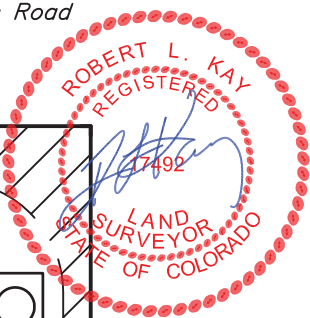
