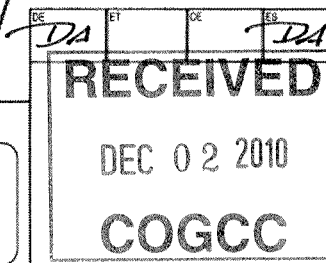

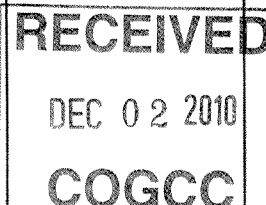

157 psi, bled down in 2 minutes through 1/2" ball valve. Brings a little fluid and builds up every day.
Pressure gradient = 0.12.

11/12/2008: We requested a 90 day vent period.

03/02/2009: 7 day buildup was 143 psi. We removed this well from the venting list.

03/10/09: 150 psi, blows dead in 3 min. We would like to vent this well again for 90 days.

07/13/2009: 7 day build up was 103 psi. We would like approval to remove this well from our venting list.
Verbal approval was given by David Andrews on 07/13/2009.

2-25-10: Built to 158 psi in 1 day, blew down in 7 seconds through 2" valve. No water.
Request approval to vent for 180 days.

11-23-10: Encana requests approval to open and vent the bradenhead on this well indefinitely. A 7-day pressure build-up will be obtained and, if that pressure builds to 150 psi or greater during that time, it will be reported on a Form 17. All 7-day build-up pressure data will be reported in our annual report.
