Hi Tony,

The COGCC is reviewing the Form 2A oil and gas location assessment for the DOUD 23-4 well location NESW Sec4 T11N R54W, Logan County, and requests the following changes or clarifications to the Form 2A submitted by SingleTree Resources, Inc:

- 1) **Facilities:** If a production pit will be on location, will a skim tank or skim pit or similar vessel be used also? Please verify whether a skim tank or skim pit will be used and I will add it to the Form 2A.
- 2) **Water Resources:** Please approve me changing the Rule 901.e. Sensitive Area Determination from Yes to No. This determination is typically made at the request of the Director and requires extensive site-specific data be supplied. Note that the Sensitive Area Decision Tree is no longer a part of the Rules.

- 3) **Hydrology Map:** The Hydrology Map must be a topographic map that shows surface waters and riparian areas within 1000 feet of the proposed location. The Hydrology Map submitted includes topographic contours, but does not show the proposed location. Please revise the Hydrology Map with the proposed location included and I will attach it to the Form 2A.
- 4) **Conditions of Approval:** Please indicate SingleTree's concurrence with the following Conditions of Approval:
 - COA 1:** Since the Land Use is Rangeland, a reference area map and photographs must be submitted. Therefore, the following condition of approval will apply to the Form 2A: "A Reference Area Map and Reference Area Photographs must be submitted within twelve (12) months of the approval of the Form 2A."
 - COA 2:** "A Form 15 Pit Permit must be approved prior to use of a production pit at the location."
