In accordance with Rule 305 of the Colorado Oil and Gas Conservation Commission ("COGCC"), this letter serves as a 30-day notice by Great Western Oil and Gas Company, LLC (GWOGC) of its intention to drill one well from the above captioned location. GWOGC operations are estimated to begin within the next thirty 30 days pending receipt of required permits, approval of title and drilling rig availability. COGCC regulations provide that the surface owner may waive the 30-day notice requirement.

In accordance with Rule 306 of the Colorado Oil and Gas Conservation Commission ("COGCC") requires written notice from the surface owner to request or waive a consultation meeting with GWOGC concerning the location of the above referenced well and all associated equipment.
