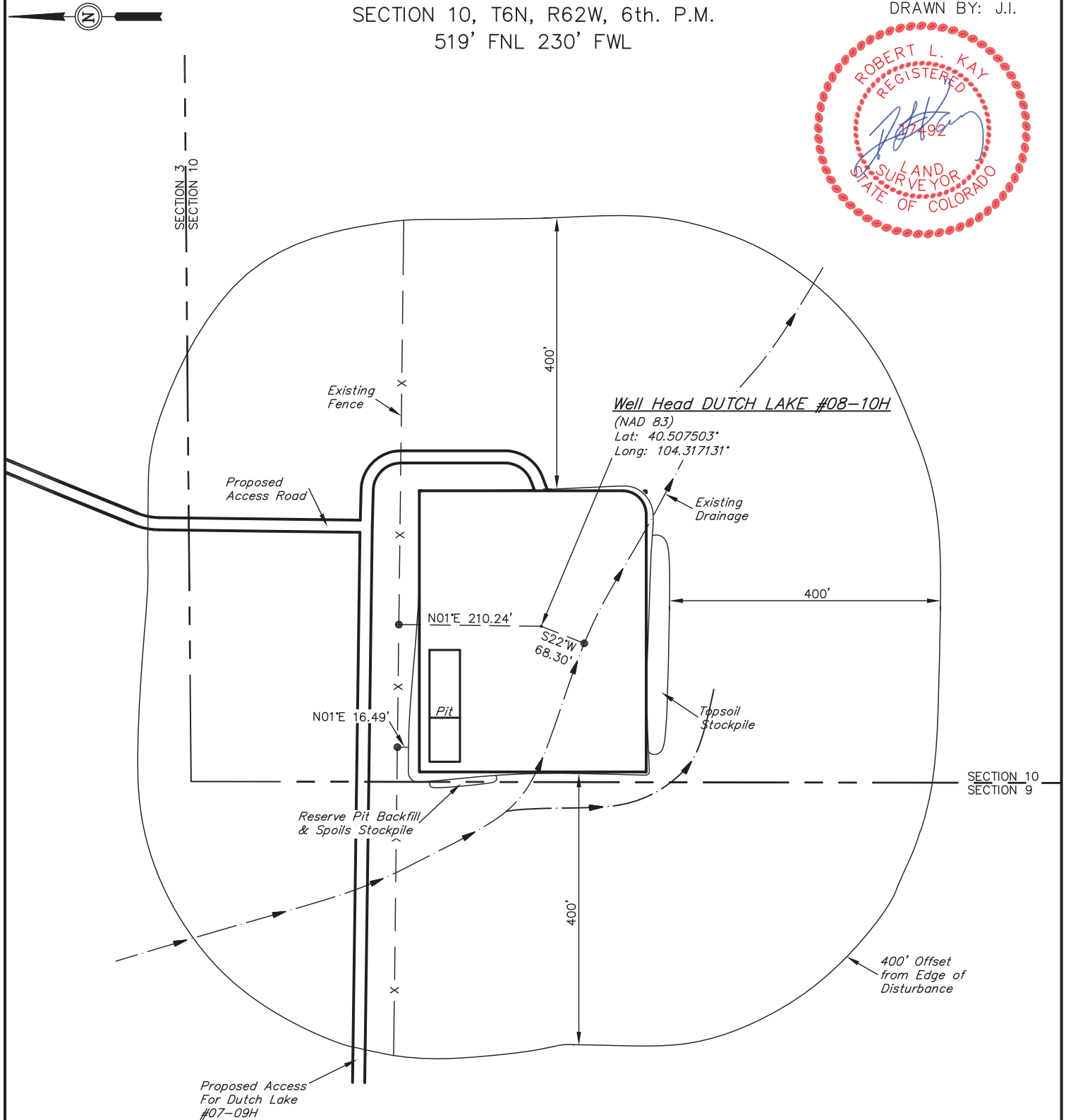

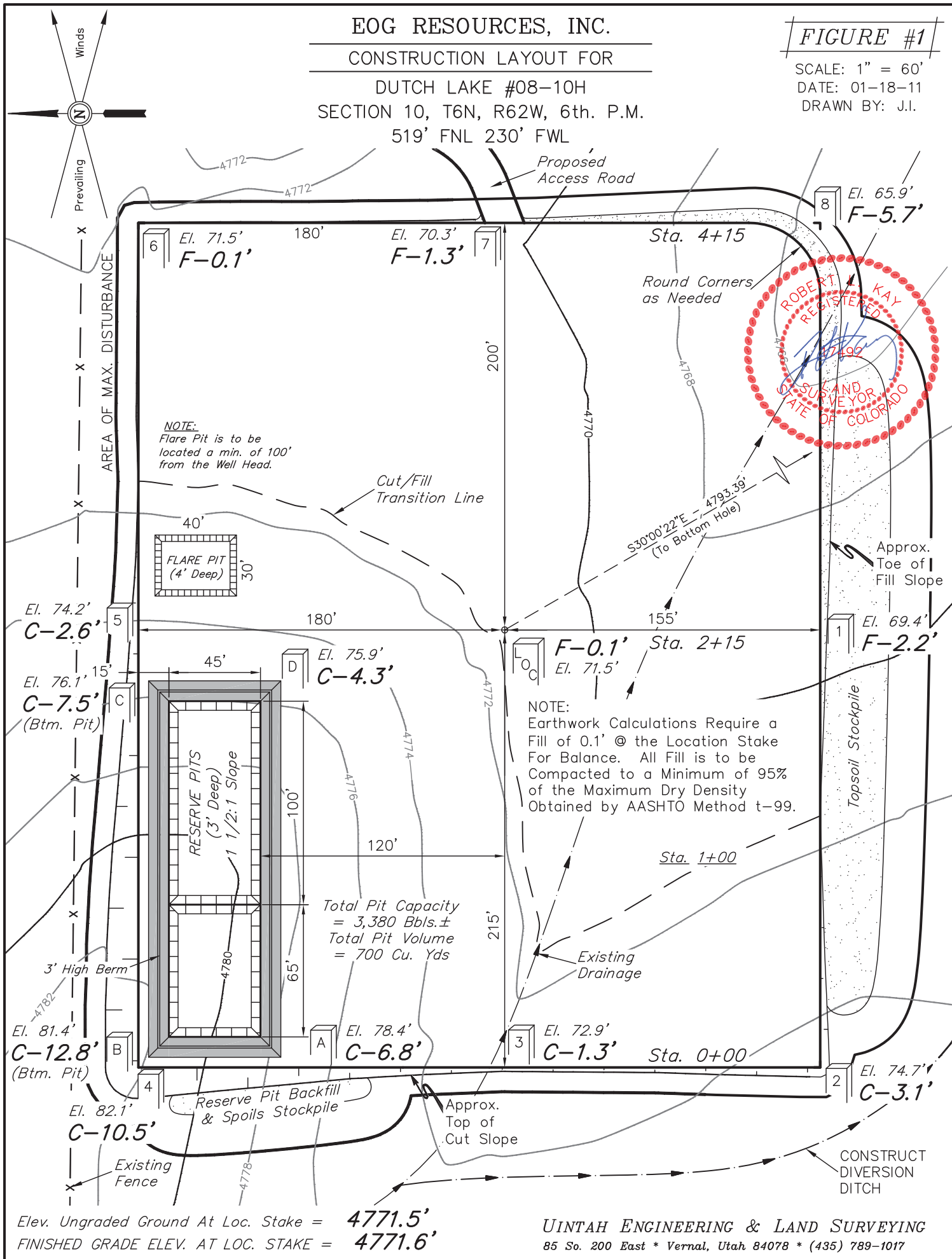

TYPICAL RIG LAYOUT FOR

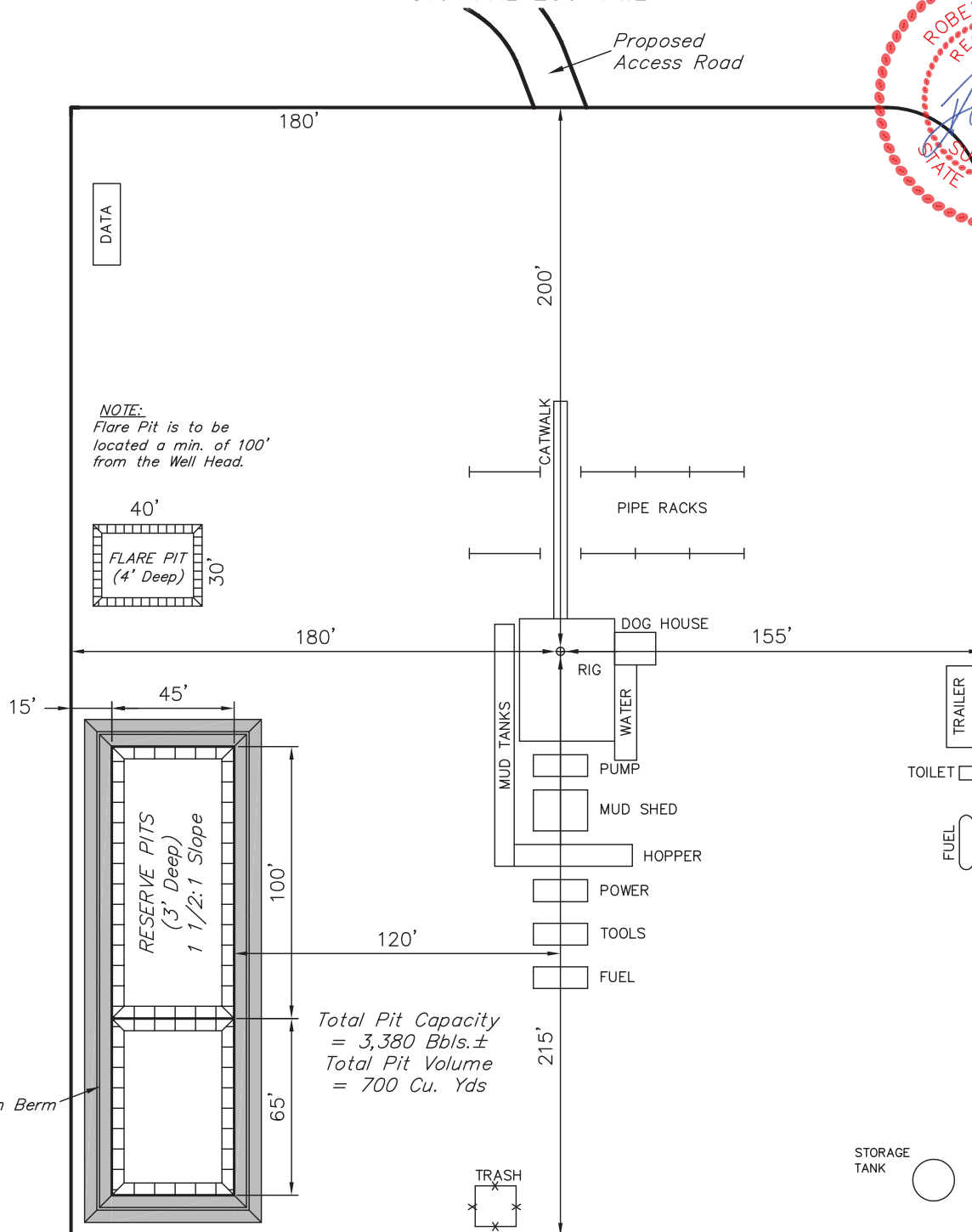

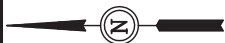

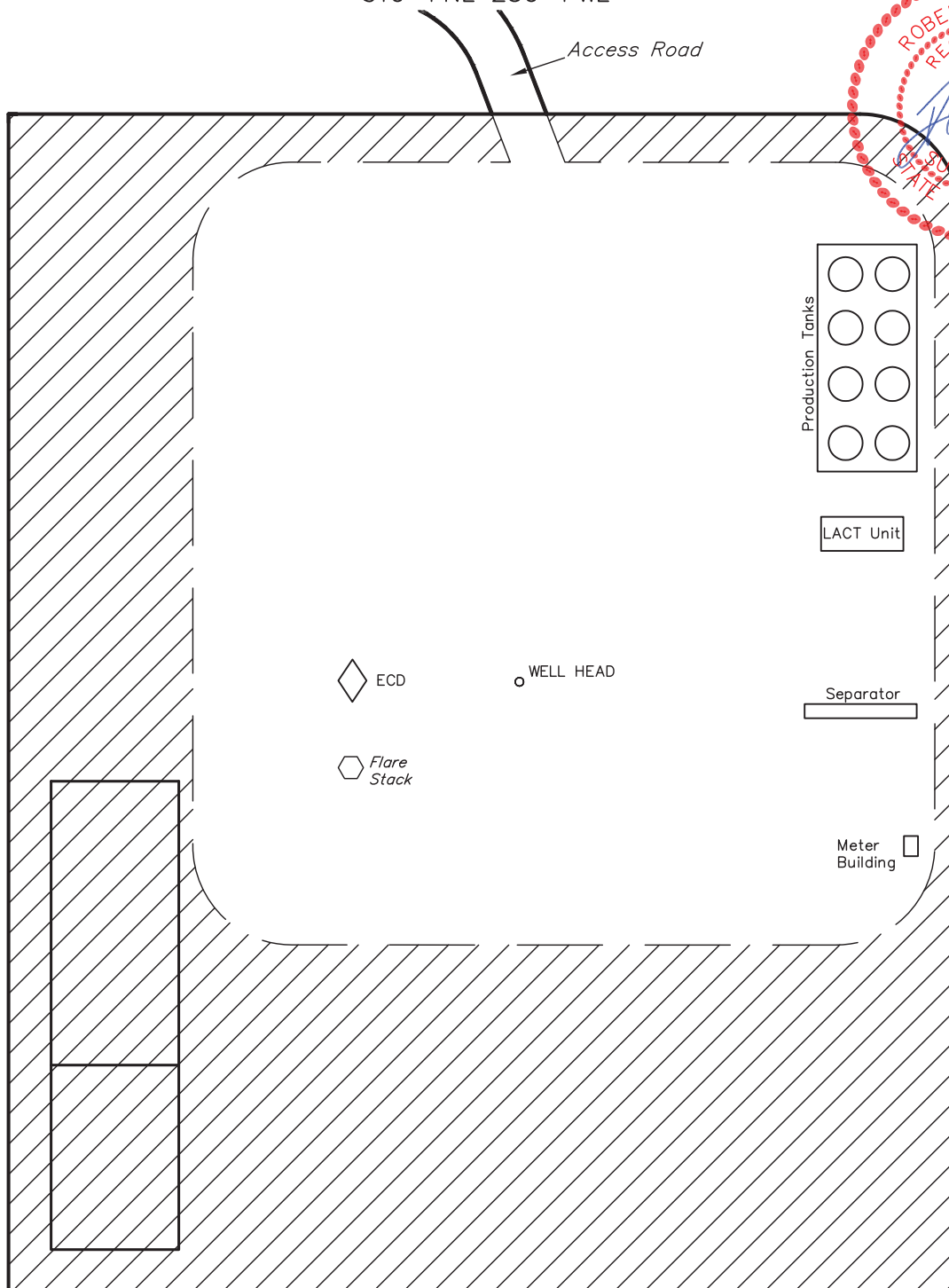
