


Lease Map – Lower Latham G12-69HN

TOWNSHIP 4 NORTH, RANGE 65 WEST, 6th P.M.

Section 12: That portion of the NW/4 described as follows: A strip of land through, upon, over and across the NW/4 of said Section 12, upon which to construct, maintain and operate an irrigation canal; said strip of land being Fifty (50) feet wide, extending Twenty-five (25) feet left and Twenty-five (25) feet right of the center line of the WEST BRANCH OF THE NERES CANAL; said center line passing through the points of the following described traverse and varying not more than Eight (8) feet from the line connecting said points; said traverse line being described as follows, to wit: BEGINNING at a point in the South line of the NW/4 of said Section 12, 191 feet West of the center of said Section 12, said point being designated Station 753+48; thence North $32^{\circ}10'$ East 50.0 feet to Station 754+00; thence North $26^{\circ}30'$ West 198.3 feet to Station 756+00; thence North $44^{\circ}16'$ West 100.0 feet to Station 757+00; thence North $38^{\circ}13'$ West 149.4 feet to Station 758+50; thence North $03^{\circ}34'$ West 198.3 feet to Station 760+50; thence North $28^{\circ}27'$ West 149.3 feet to Station 762+00; thence North $42^{\circ}35'$ West 398.6 feet to Station 766+00; thence North $18^{\circ}26'$ West 250.0 feet to Station 768+50; thence North $06^{\circ}34'$ West 99.2 feet to Station 769+50; thence North $65^{\circ}32'$ East 96.1 feet to Station 770+50; thence North $83^{\circ}27'$ East 648.0 feet to Station 777+00; thence North $57^{\circ}38'$ East 149.8 feet to Station 778+50; a point in the East line of the NW/4 of said Section 12, 1034 feet South of the North quarter corner of said Section 12. Containing 2.87 acres.

ALSO, a strip of land through, upon, over and across the NW/4 of Section 12, upon which to construct, maintain and operate an irrigation canal; said strip of land being Ninety-three (93) feet wide, extending Fifty (50) feet left and Forty-three (43) feet right of the center line of the GILMORE CANAL, excepting where said center line passes through the right of way of the county road; said center line being described as follows, to wit: BEGINNING at a point in the South line of the NW/4 of said Section 12, 780 feet East of the West quarter corner of said Section 12, said point being designated Station 430+12.5; thence by a $46^{\circ}12'$ curve left 105.5 feet from a tangent bearing North $35^{\circ}02'$ East to Station 431+18 P.T.; thence North $12^{\circ}42'$ West 382 feet to Station 435+00 P.C.; thence by a $20^{\circ}00'$ curve left 150 feet to Station 436+50 P.T.; thence North $42^{\circ}42'$ West 100 feet to Station 437+50 P.C.; thence by a $40^{\circ}00'$ curve right 250 feet to Station 440+00 P.R.C.; thence by a 40° curve left 300 feet to Station 443+00 P.R.C.; thence by a $15^{\circ}00'$ curve right 250 feet to Station 445+50 P.C.C.; thence by a $25^{\circ}20'$ curve right 150 feet to Station 447+00 P.T.; thence North $12^{\circ}48'$ East 300 feet to Station 450+00 P.C.; thence by a $9^{\circ}28'$ curve right 150 feet to Station 451+50 P.T.; thence North $27^{\circ}00'$ East 100 feet to Station 452+50 P.C.; thence by a $16^{\circ}48'$ curve left 150 feet to Station 454+00 P.T.; thence North $01^{\circ}48'$ East 350 feet to Station 457+50 P.C.; thence by a $36^{\circ}40'$ curve right 187.6 feet to Station 459+37.6 P.T.; thence North $70^{\circ}36'$ East 54 feet to Station 459+91.6, which is equal to Station 460+00; thence North $70^{\circ}36'$ East 15 feet to Station 460+15, a point in the North line of said Section 12, 727 feet East of the Northwest corner thereof; and again

BEGINNING at a point in the North line of said Section 12, 1040 feet East of the Northwest corner of said Section 12, said point being designated Station 463+53; thence South $64^{\circ}22'$ East 897 feet to Station 472+50 P.C.; thence by a $46^{\circ}06'$ curve left 180 feet to Station 474+30 P.R.C.; thence by a $41^{\circ}20'$ curve right 202 feet to Station 476+32 P.T.; thence South $63^{\circ}47'$ West 146 feet to Station 477+78, which is equal to Station 483+98.3 (Station 477+78 back equals Station 483+98.3 ahead); thence North $21^{\circ}49'$ East 126.2 feet to Station 485+24.5 P.C.; thence by a $42^{\circ}00'$ curve left 275.5 feet to Station 488+00 P.R.C., a point in the North line of the NW/4 of Section 12, 2233 feet East of the Northwest corner of said Section 12, containing 10.97 acres.
