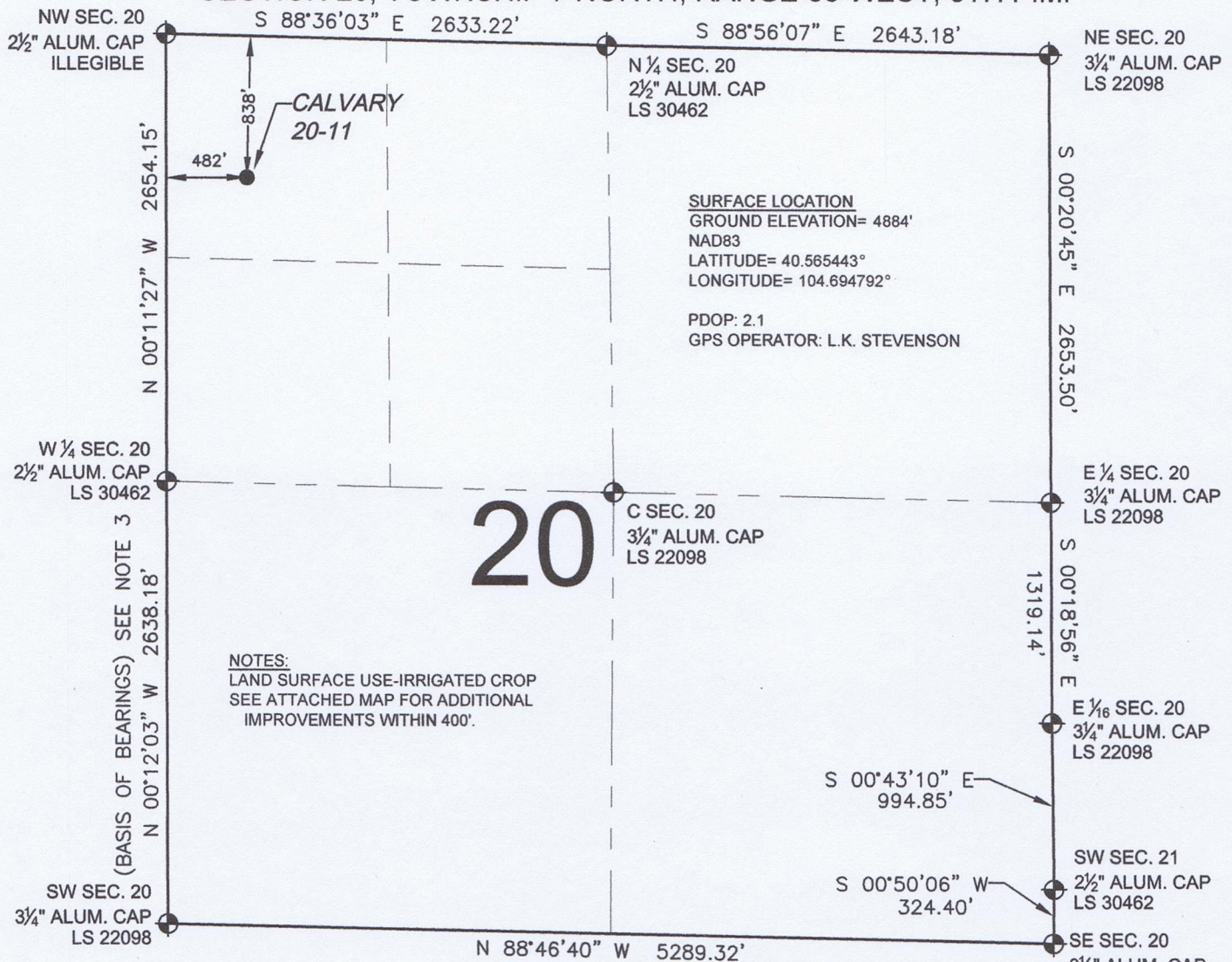


WELL LOCATION CERTIFICATE: CALVARY 20-11

SECTION 20, TOWNSHIP 7 NORTH, RANGE 65 WEST, 6TH P.M.

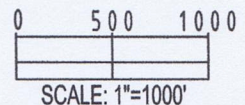


NOTES:
