Oxy is both the surface and mineral owner; Rules 305 and 306 are waived. The well pad has not been constructed. A semi-closed loop system will be used. Per GarCo Vacation Ordinance dated 10-5-1987, CR 213 is now OXY's private property north of Sec 8, 7S, 97W, 6 PM. Oxy will provide appropriate housing for essential personnel in order to conduct safe, efficient drilling operations at this well site. The plats reference a "blooie pit;" this is not a pit but a flare box. Oxy will comply with Notice to Operators (NTO) Drilling wells on the Roan Plateau (June 12, 2008). The CDOW pre-consultation meeting occurred on February 11, 2011.
