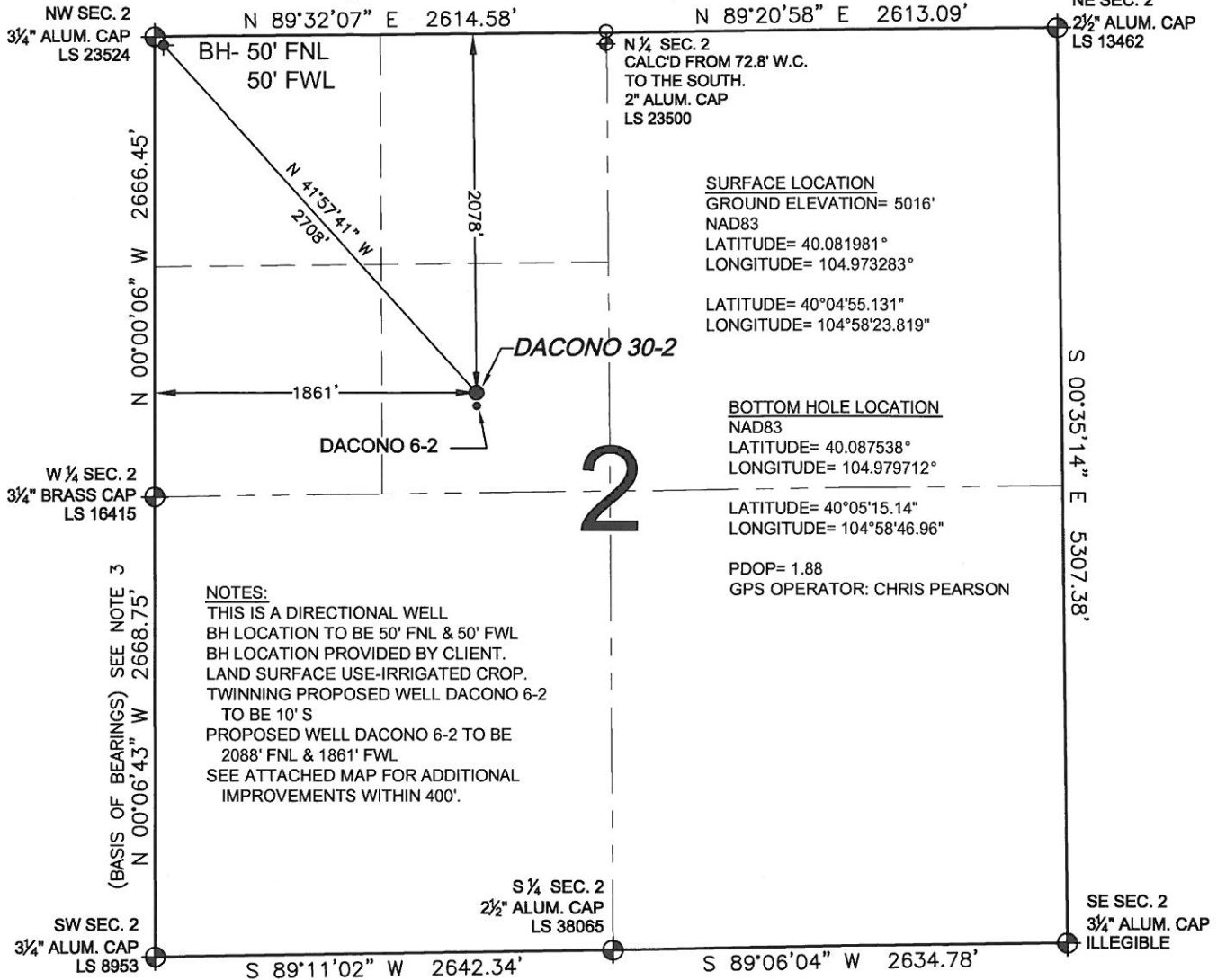


# WELL LOCATION CERTIFICATE: DAcono 30-2

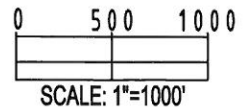
SECTION 2, TOWNSHIP 1 NORTH, RANGE 68 WEST, 6TH P.M.
