Ladies and Gentlemen:

This letter serves as advance notice by EnCana Oil & Gas (USA) Inc. (“EnCana”) of its intention to conduct drilling operations on the captioned wells located on your property. EnCana’s operations are estimated to begin in the 3rd quarter of 2011 pending receipt of required permits, approval of title and drilling rig availability.

EnCana’s representative, Dave Bale, will be contacting you within the next several weeks to schedule a consultation to discuss the location of the wellsites, access roads, production facilities and other related matters (please see the enclosed plats). Enclosed for your review is an informational copy of COGCC’s notification, consultation and reclamation rules regarding oil and gas operations.

The COGCC regulations provide that the surface owner may designate a representative for surface consultation. Enclosed is an owner response form and we ask that you indicate your preference with regard to the consultation requirement and return the form in the self-addressed stamped envelope provided for your convenience.






