Railroad is 2,760 ft +/- away from site. County Road 34 is 350 ft north of site; no other visible improvements within 400 ft of site. Nearest water well 2,676 ft +/- from site (RECEIPT: 0416076; PERMIT: 68215-A; USE: DOMESTIC STOCK). There is an ephemeral stream located 1,062 +/- feet south of location. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COAs are needed for this location. This is a water disposal well to inject Niobrara Formation produced water into the Lower Cretaceous sands (D-Sand, J-Sand, Dakota Sands) at a depth of approximately 3,900 feet below the surface.
