Hi Nanette,

The COGCC is reviewing the Form 2A oil and gas location assessment for the GEARY CREEK 03-10H & 06-10H well location in the NWNW Sec10 T10N R63W, Weld County, and requests the following changes to the Form 2A:

- 1) **Water Resources:** Although the surveyor identified a water well 6294 feet from the location, the DWR database shows a water well to be located closer to the location - well permit no. 37124 which is located 3395 feet from the location. Aerial photography also provides evidence that there is a water well at or near this location. Therefore, please approve me changing the distance to nearest water well to 3020 feet.
- 2) **Multi Well Plan:** A multi-well plan must be attached with the Form 2A. Please submit a multi-well plan that shows the surface with proposed well bore trajectory and bottom-hole locations for each well.
