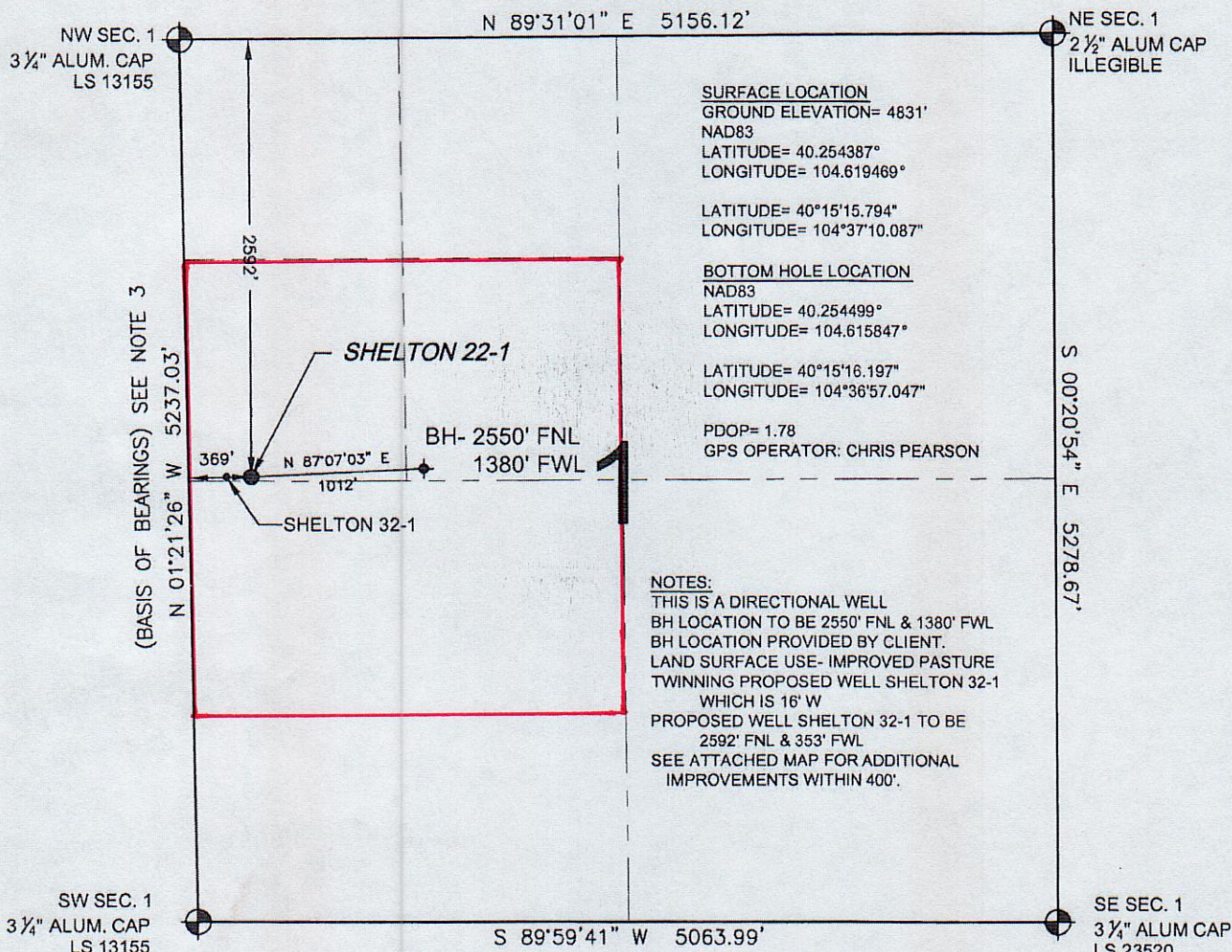

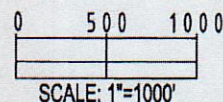
WELL LOCATION CERTIFICATE: SHELTON 22-1

● = PROPOSED WELL ◆ = EXISTING WELL

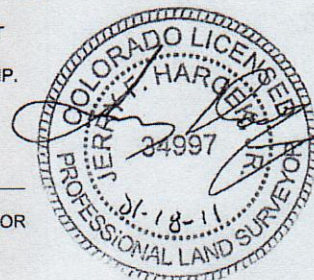

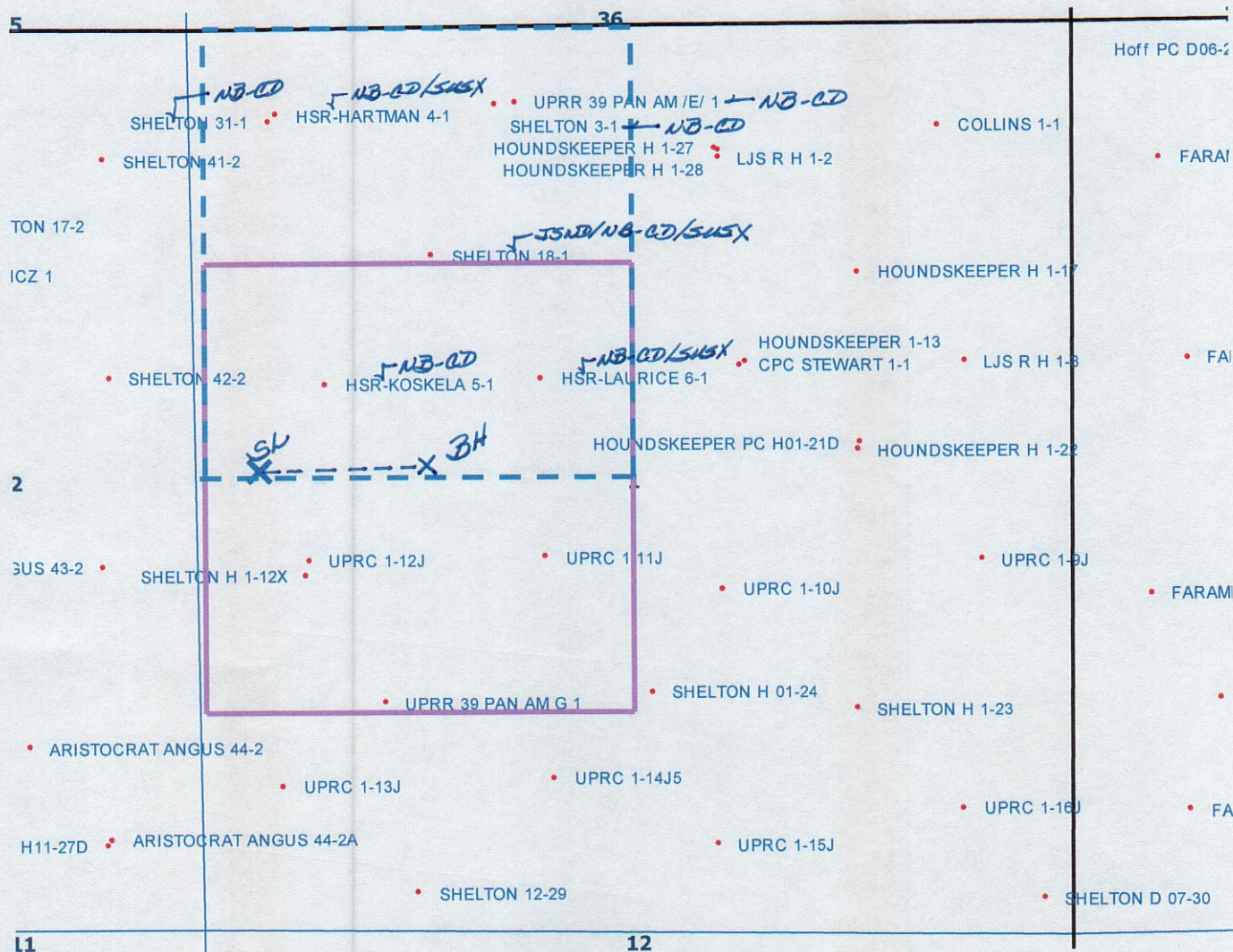
