Storm Water/Erosion Control	2. Vehicle Tracking and Sediment – A stabilizing granular material is anticipated for the access road and pad which will prevent sediment transfer.
Storm Water/Erosion Control	3. Significant Dust or Particulate Generating Processes – It is anticipated that temporary stabilization through seeding or tackifier will be used to contain dust or particulate.
