Railroad is 1.52 +/- miles away from site. Visible Improvements: County Road 51 is 205 feet which is within 400 feet of the site. Nearest water well 739.21 +/- feet from site (RECEIPT:0270785B; PERMIT:146748-A;USE: DOMESTIC STOCK). Static Water Level was taken from next nearest water well Permit no. 278127-A. The well location is on the edge of a dry, ephemeral playa. The pit will be upside and out of the playa. The Meter Run Shed will be placed close to the road. This location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COAs are needed for this location. A Pump Jack may be necessary to place on facility in the future to help with gas production. It will require either one gas or one electric motor to run the pumping jack unit which will be determined at the time of installation.
