Public	<p>This proposed well and tank battery is located unnecessarily close to our property boundary at 38251 CR 29. It's our understanding that the tank battery will be east of the well.A battery of tanks will obstruct our view of the mountains</p> <p>and the truck traffic in maintaining the well will be noisy and intrusive.We are more concerned about the tank battery location than the actual well location, and request that the well and tank battery be placed as far West or South from our property as possible and that they be low profile with screening. We've been told that the well and tank battery can't</p> <p>be moved to the west or south because of the floodplain. In checking with County officials, we've learned that with the appropriate permit and midigation (tank tie down), tanks can be located in a floodplain.
