

1. Wellbore Spacing Unit  
The wellbore spacing unit will be comprised of the S $\frac{1}{2}$ SW $\frac{1}{4}$  of Section 10 and the N $\frac{1}{2}$ NW $\frac{1}{4}$  of Section 15 in T5N, R65W as depicted on the enclosed plat. The working interest attributable to the Codell/Niobrara formations in the contributing 40 acre quarter-quarter section will be utilized to determine the interest of the parties in the proposed 160 acres spacing unit for this well
2. Target Formations  
This well will be drilled to a total depth to sufficiently test the Codell/Niobrara formations.

Surface Location: 417' FSL, 1016' FWL, Section 10, T5N, R65N  
Bottom Hole Location: 100' FSL, 1320' FWL, Section 10, T5N, R65W

Third Quarter 2011




