



In accordance with a request from RYAN ANTONIO with NOBLE ENERGY INC. King Surveyors Inc. has determined the surface location of the DRAKE PC MM14-08D to be 1831' from the SOUTH line and 1870' from the EAST line and the bottom hole to be 1980' from the NORTH line and 660' from the EAST line, as measured at right angles, from the section lines of Section 14, Township 7 North, Range 67 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 4-19-2011, for and on behalf of NOBLE ENERGY INC. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
