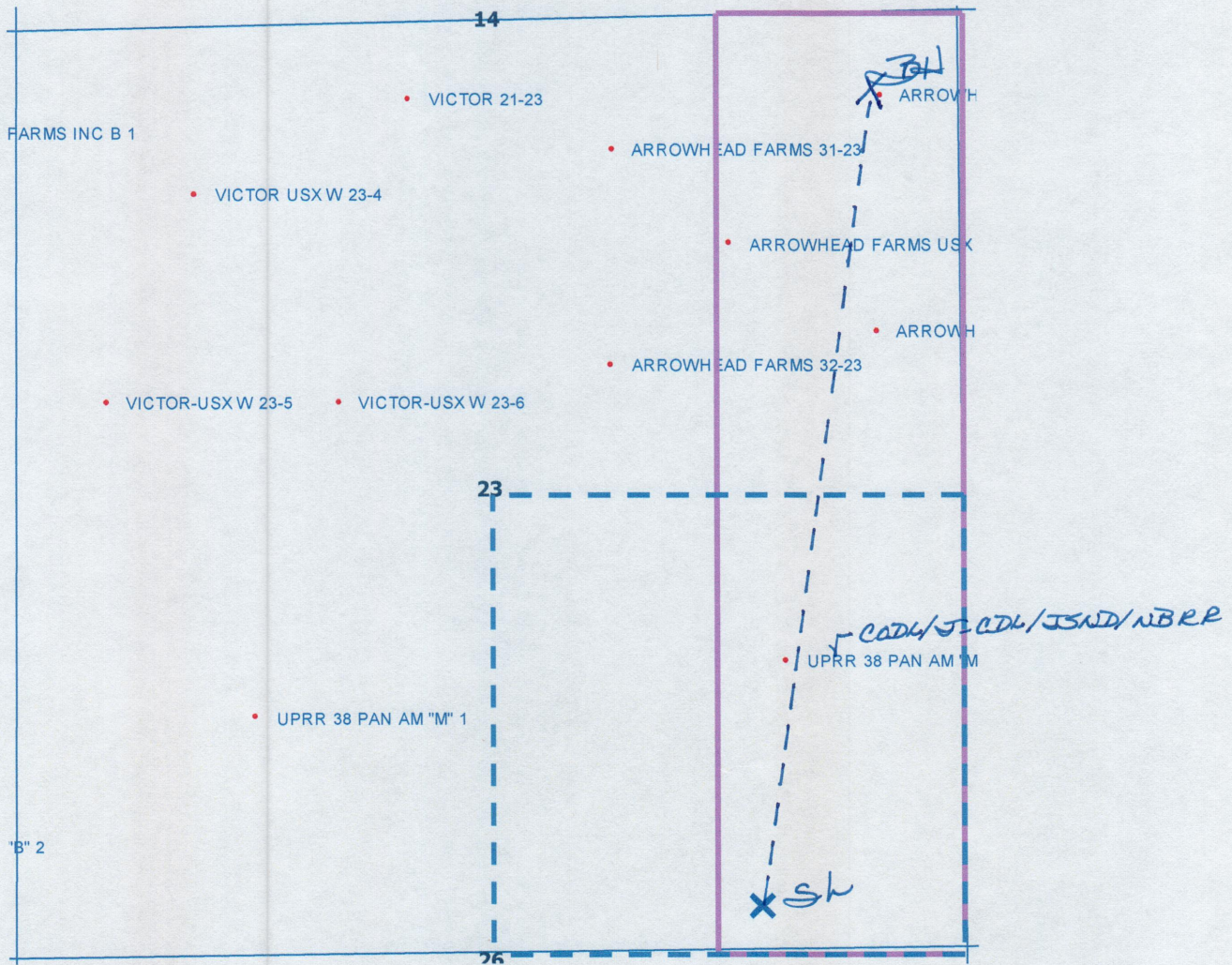

Proposed 160 acre Spacing Unit (Solid line).

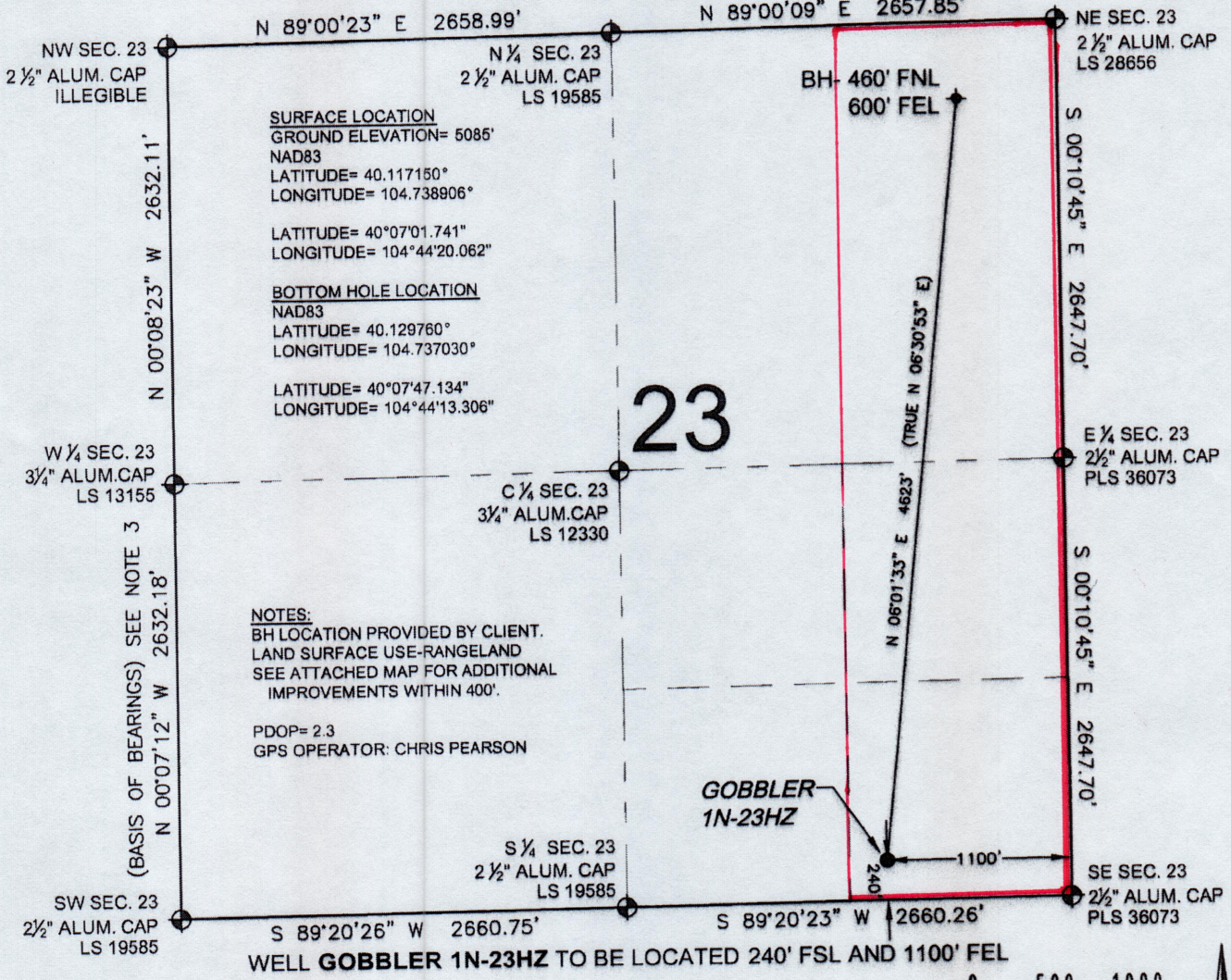


Bottom Hole Located NE/4NE/4, Sec. 23-T2N-R66W (Dashed line).
