Flare stack will be removed after a gas line is installed. One of two heater treaters will be removed when production volumes fall below the capacity of a single heater treater. Depth to ground water was determined from the nearest Water Well Permit No. 3741 per the COGCC GIS information. This water well lies to the northeast of the location in Sec. 17 T6N R61W. The closest water well per the location drawing is located to the northeast of the location in Sec. 16 T6N R61W.
