Brendan,

I spoke with Dave Segobia yesterday, Thursday, May 26, 2011 about adding some wildlife, wildlife habitat best management practices to your 2A permits for the Gulfport Ellgen 11-10-1 and State 41-14-1.

He seemed to be open and willing to add 2 BMPs to each of the permits. But I want to touch base with you as well to confirm that both of you are on the same page about adding them.

The best management practices I would like you to add to the Gulfport Ellgen 11-10-1 and State 41-14-1. are:

- Schedule construction and drilling operations for summer (outside the time period from December 1 through April 15).
- Use wildlife friendly seed mix in interim and final reclamation.

I believe that your construction and drilling time frame, barring changes, align with our requested refrain from drilling, so hopefully you can agree to this.

Also we would ask that you use wildlife friendly seed mix in your interim and final reclamation. We recognize that the landowner has a final say in the matter but if the landowner is agreeable the CDOW believes it would provide the best reclamation solution for all.

Also, I have attached a list of oil and gas best management practices (BMPs) for wildlife and wildlife habitat protection. The first part of the document is general/field wide BMPs and the second part lists species specific BMPs. We hope that you will use this BMP list in conjunction with the COGCC wildlife habitat mapping tool on their web site to develop wildlife management practices for oil and gas developments.

If you agree to the above BMPs please let me know. Also if you do agree to the above two BMPs will you please let me know in an email and copy Dave Kubeczko at COGCC, his email is [Dave.kubeczko@state.co.us](mailto:Dave.kubeczko@state.co.us)
