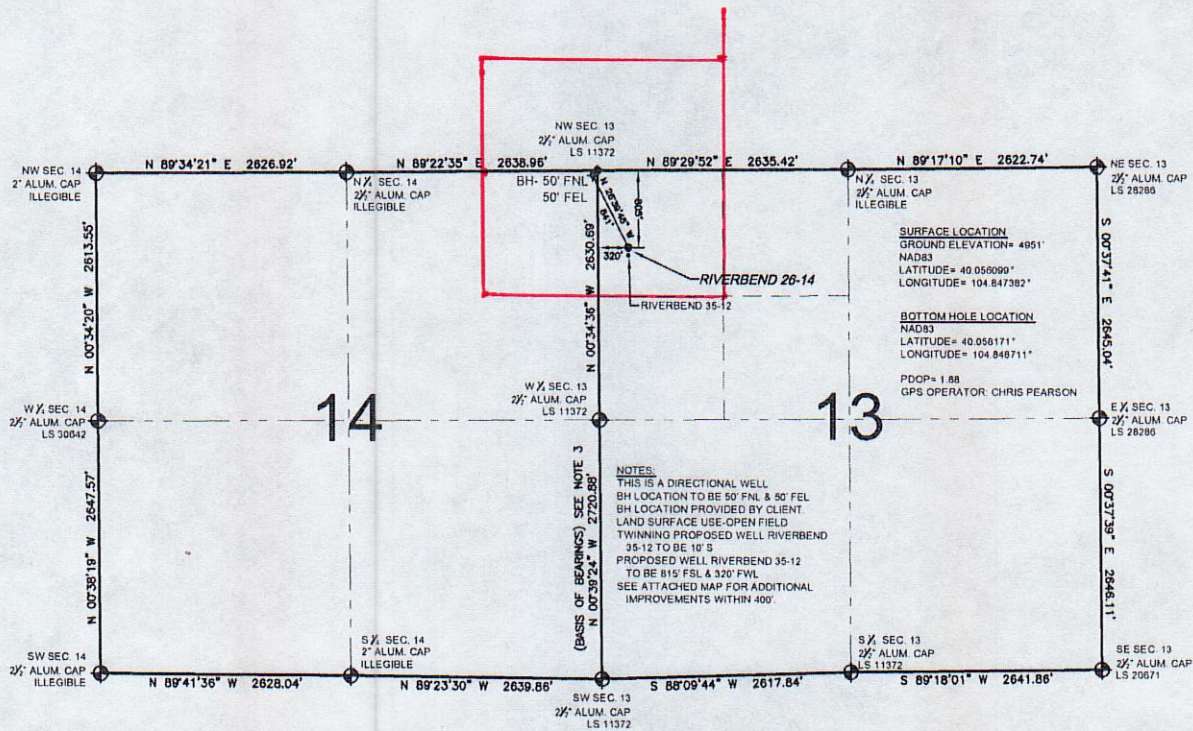

WELL LOCATION CERTIFICATE: RIVERBEND 26-14

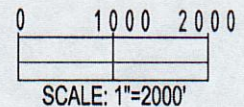
SECTION 13, TOWNSHIP 1 NORTH, RANGE 67 WEST, 6TH P.M.

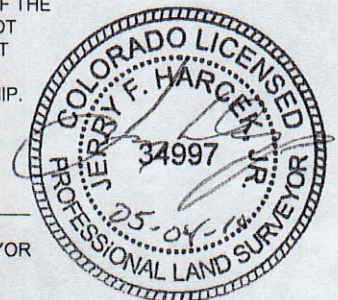

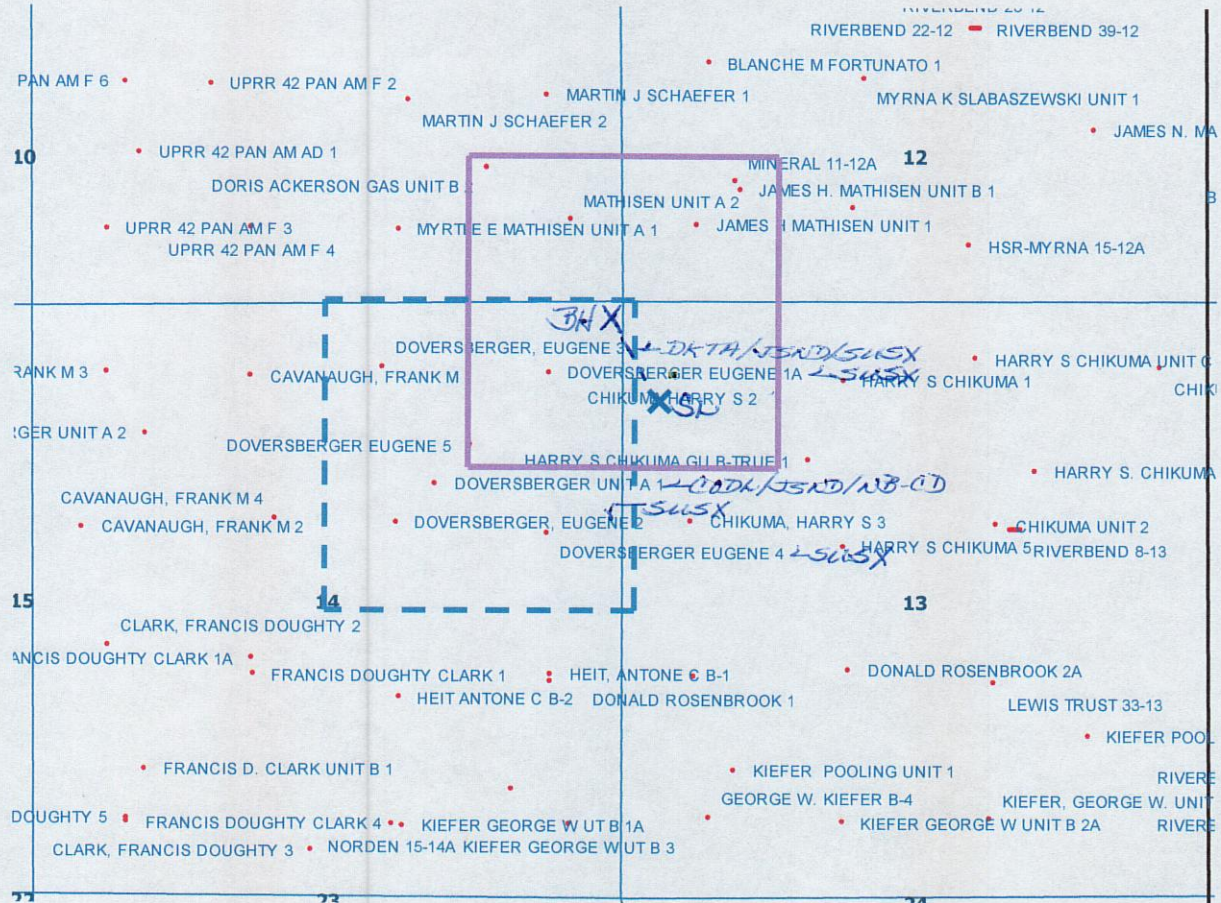
