Railroad is 5135 +/- feet away from site. There are no visible improvements within 400 feet of the site. The Leben 12-33, which is a P&A'd well is approx. 295 feet southwest of site. Nearest water well 2438 +/- feet from site (RECEIPT:9053325; PERMIT:379;USE: DOMESTIC). There is a dry, ephemeral playa located 1665+/- feet south of location. This location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COAs are needed for this location. A Pump Jack may be necessary to place on facility in the future to help with gas production. It will require either one gas or one electric motor to run the pumping jack unit which will be determined at the time of installation.
