Railroad is 2.90 +/- miles away from site. There is an underground pipeline approx. 212 feet east of site and the lot line is within 469 feet of the site. Nearest water well approx. 4833 +/- feet from site (RECEIPT:0452376A; PERMIT:221503; USE: DOMESTIC STOCK). There is a small, dry, ephemeral playa located 404 +/- feet northeast of location. This location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COAs are needed for this location. A Pump Jack may be necessary to place on facility in the future to help with gas production. It will require either one gas or one electric motor to run the pumping jack unit which will be determined at the time of installation.
