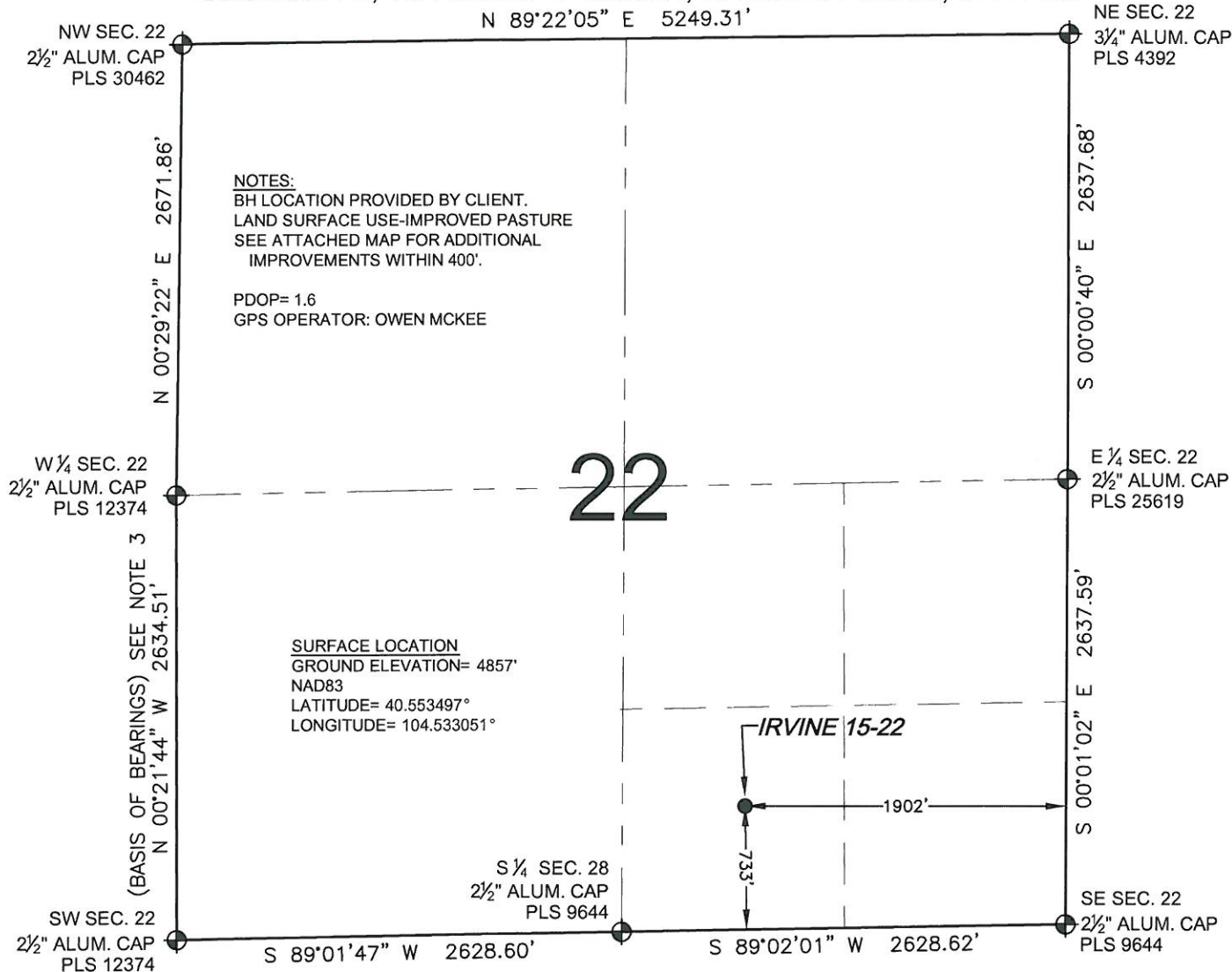


WELL LOCATION CERTIFICATE: IRVINE 15-22

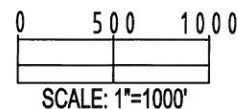
SECTION 22, TOWNSHIP 7 NORTH, RANGE 64 WEST, 6TH P.M.

● = PROPOSED WELL ◆ = EXISTING WELL

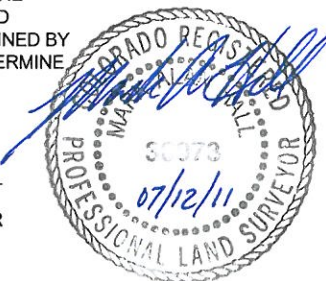
