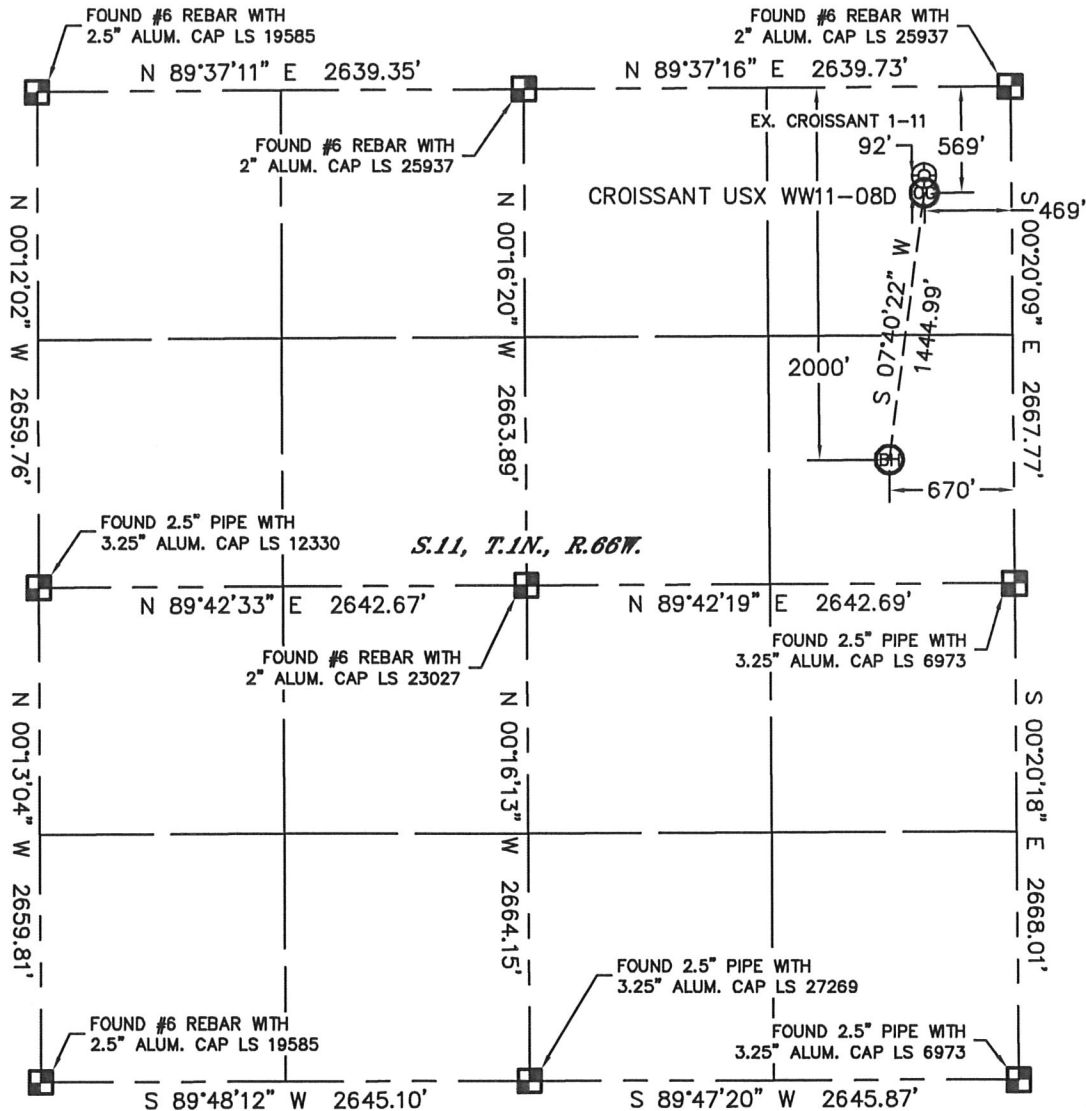

In accordance with a request from Matt Campbell with Noble Energy Inc. Lat40°, Inc. has determined the surface location of the CROISSANT USX WW11-08D to be 569' from the NORTH line and 469' from the EAST line and the bottom hole to be 2000' from the NORTH line and 670' from the EAST line as measured at right angles from the section lines of Section 11, Township 1 North, Range 66 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 5/12/11, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future Improvement lines.

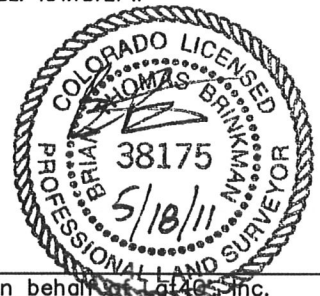

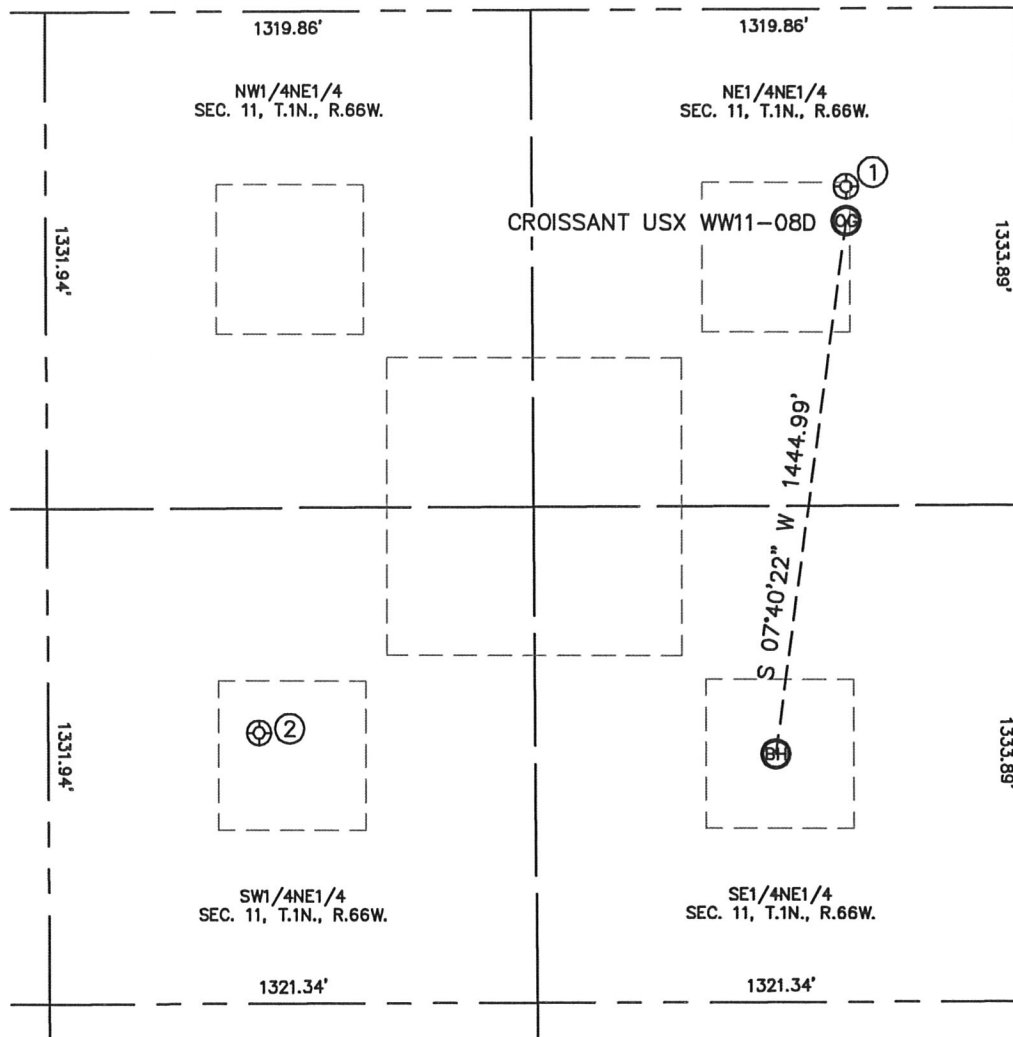
