A Subsequent Report of Abandonment shall indicate the actual work completed. - 4) If unable to plug as prescribed, contact COGCC for changes in plugging orders.
- 5) Monthly Report of Operations, Form 7 required from spud to abandonemnt - submit these reports to COGCC prior to Subsequent Report of Abandonment.
- 6) Confirm open hole dimension on Subsequent Report of Abandonment.
