RAILROAD IS 1.76 +/- MILES AWAY FROM SITE. THERE ARE NO VISABLE IMPROVEMENTS WITHIN 400 FEET OF SITE. NEAREST WATER WELL 2625 +/- FEET FROM SITE ( RECEIPT:9053495; PERMIT 12357-F- USE: DOMESTIC). THERE IS A CREEK 553 FEET NORTH EAST OF LOCATION. A PUMP JACK MAY BE NECESSARY TO PLACE ON FACILITY IN THE FUTURE TO HELP WITH GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR TO RUN THE PUMPING JACK UNIT WHICH WILL BE DETERMINED AT THE TIME OF INSTALLATION.
