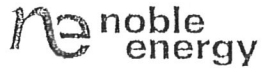

Weld County Assessor records indicate you own the surface of the captioned lands. Colorado Oil and Gas Conservation Commission Rule 305.e. (1).B requires that you be given thirty (30) days advance notice of planned oil and gas operations on the captioned lands. Please be advised that Noble Energy, Inc. ("Noble") plans to commence operations for the drilling of the captioned well on or about March 2011. Enclosed are (1) A preliminary plat showing the approximate location of the planned well and the associated facilities and roads. (2) The Informational Brochure for Surface Owners entitled Oil and Gas Well Notification, Consultation and Reclamation. It contains the rules pertaining to notice of oil and gas operations and opportunities for consultation, the rules of procedure for filing complaints and making applications for hearing, the Commission's main office, field offices and website, and the local governmental designees. (3) A postage-paid, return-addressed post card through which you may request consultation.
