



In accordance with a request from SCOTT LEWIS with NOBLE ENERGY INC. King Surveyors Inc. has determined the surface location of the BEVJAC ZP10-1H to be 600' from the NORTH line and 376' from the WEST line, and the bottom hole to be 660' from the SOUTH line and 2013' from the EAST line, as measured at right angles, from the section lines of Section 10, Township 11 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 2-25-2011, for and on behalf of NOBLE ENERGY INC.
