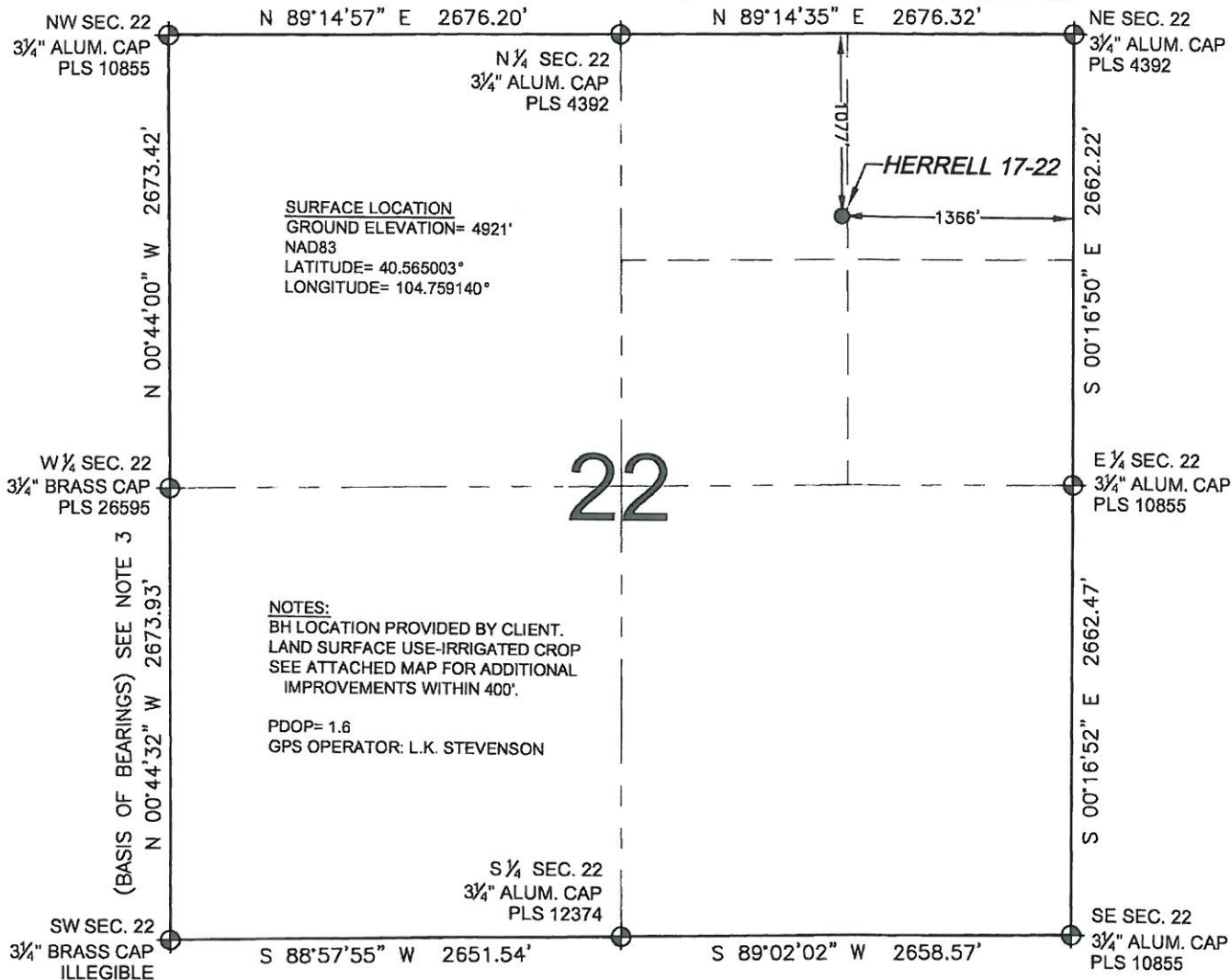


WELL LOCATION CERTIFICATE: HERRELL 17-22

SECTION 22, TOWNSHIP 7 NORTH, RANGE 66 WEST, 6TH P.M.



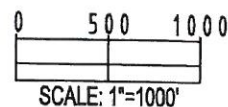
