Railroad is 1.77 +/- miles away from site. An ephemeral stream, irrigation water well and the tower tracks from the irrigation system are identified on the location drawing. Nearest water well 414 +/- feet from site (RECEIPT:9053653; PERMIT:15332-FP;USE: IRRIGATION). There is a dry, ephemeral stream located 239 +/- feet north of location. This location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COAs are needed for this location. A Pump Jack may be necessary to place on facility in the future to help with gas production. It will require either one gas or one electric motor to run the pumping jack unit which will be determined at the time of installation.
