Flare stack will be removed after a gas line is installed. One of two of the heater treaters will be removed when production volumes fall below the capacity of a single heater treater. Depth to ground water information determined from Water Well Permit #229499, which is located southeast of the proposed well in the NW4 of Section 2, T4N, R62W. It is also the closest well to the proposed well. The closed loop system utilized to drill the referenced well is a semi closed loop system. Drilling mud and cuttings will be hauled to an authorized disposal facility.
