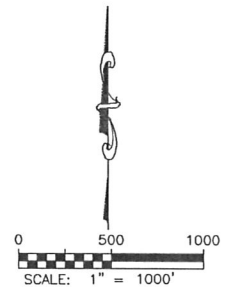
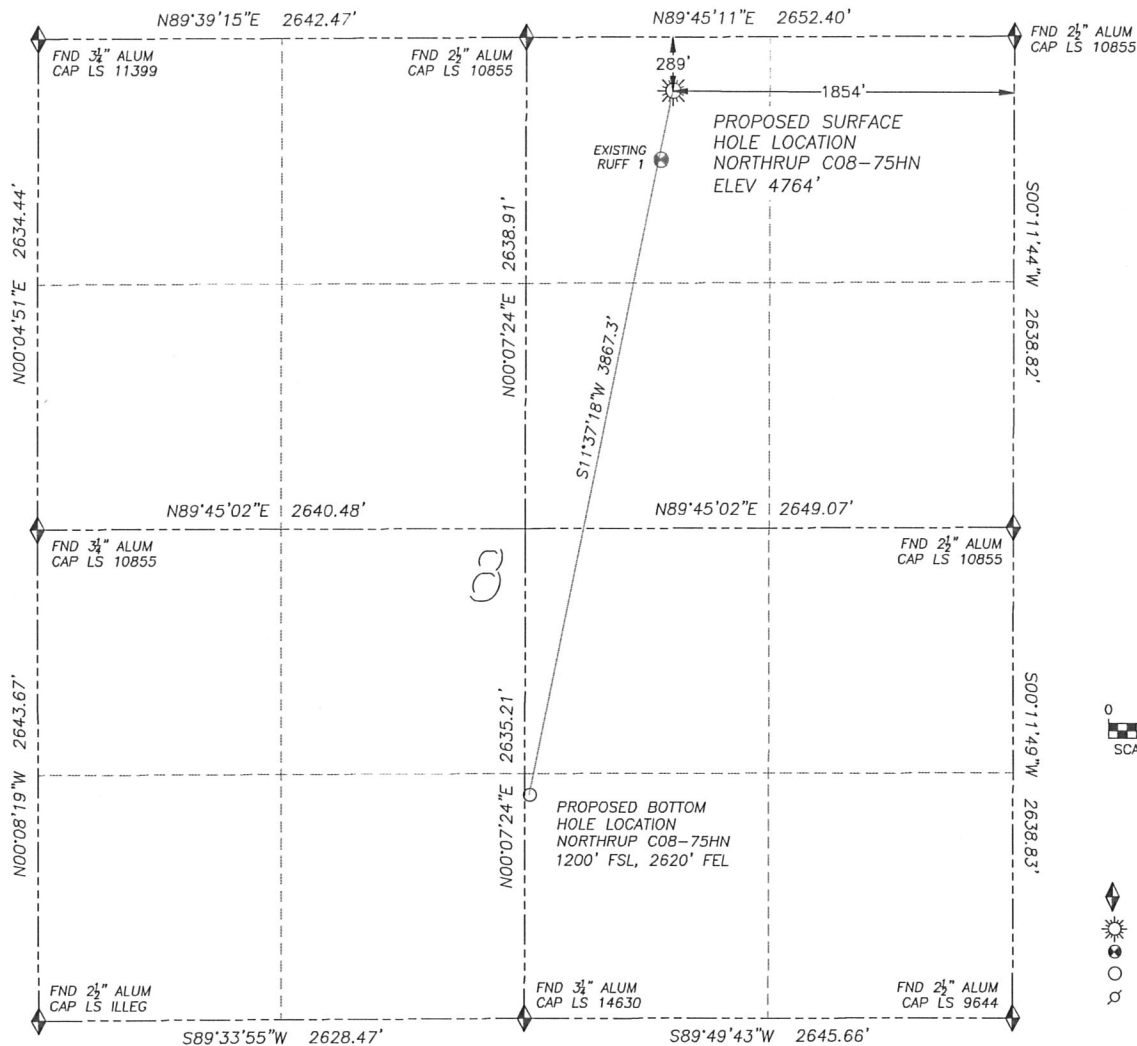


# WELL LOCATION CERTIFICATE NORTHROP C08-75HN

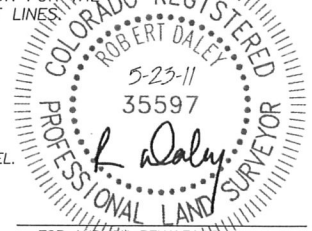

THE BOTTOM HOLE LOCATION, PROVIDED BY THE CLIENT, IS TO BE 1200' FSL, 2620' FEL.

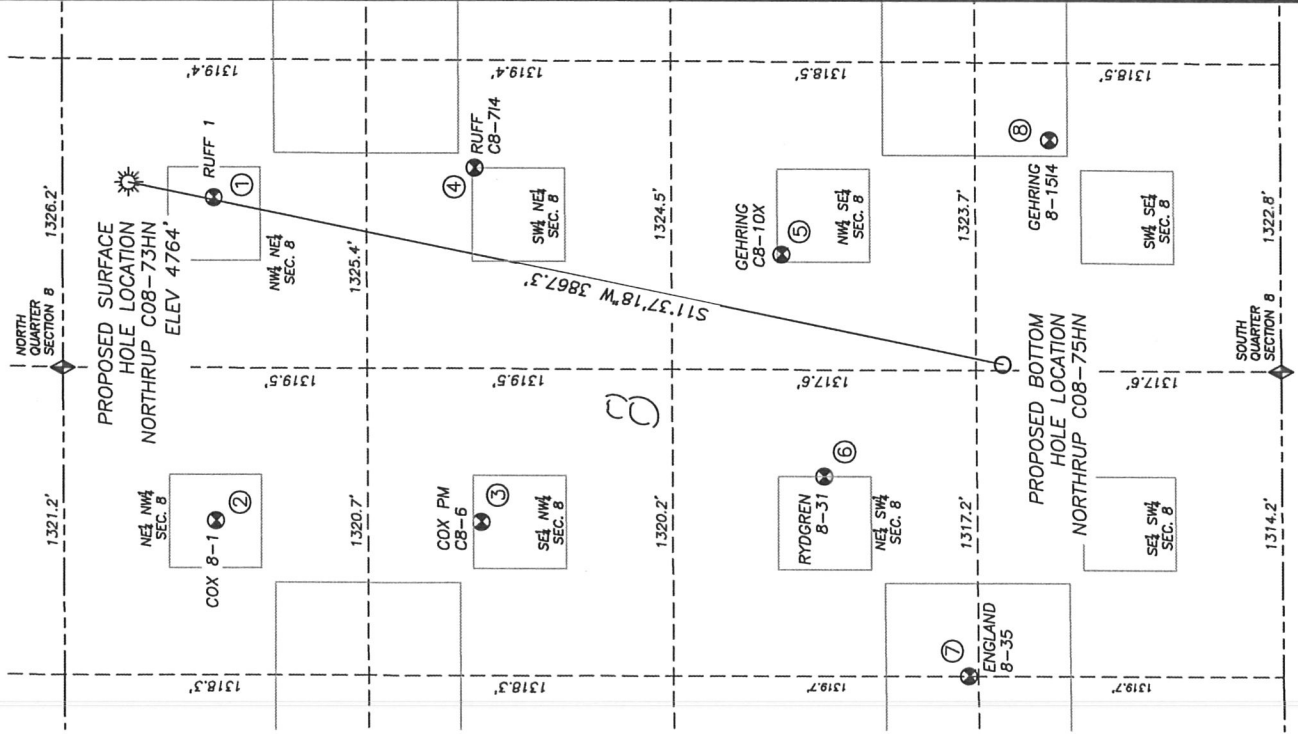
